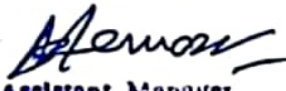

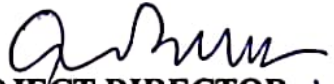

1. Eligibility:

This invitation for E-Bids is open to all Bidders, meeting the following requirements:

- Registration with PPRA, including the use of EPADS, and the Pakistan Engineering Council (PEC) renewed for the year 2024-25 for the financial categories and codes specified for each work. The bidder must demonstrate three (03) years of experience in the field of construction as per the required registration category and codes of the Pakistan Engineering Council (PEC).
- A Bidder/JV shall be a natural person, private entity, or government-owned enterprise who is in active tax payer list and registered with Federal Board of Revenue and Sindh Revenue Board
- The Bidder/JV must have submitted at least two (02) work orders, each accompanied by satisfactory performance or completion certificates, for each NCB within the last Five (05) years, related to works of similar nature and scope. However, at least one work order shall be of a value greater than 50% of quoted amount, along with a satisfactory performance or completion certificate, will also be acceptable, provided it meets the same nature and scope requirements within the last five (05) years.
- Bidder/JV having three (03) or more pending works at his end within the last two (02) years in GSC HESCO shall not be eligible to participate in the tender.
- The Bidder shall have to provide the following duly certified / audited financial record for the last 03 years from a recognized firm registered with Institute of Chartered Accountants of Pakistan (ICAP).

Tender cost/fee non refundable @Rs.5,000.00 {Five Thousand only} for each NCB shall be deposit online in ABL bank, IBAN: PK06ABPA0010003504650240 of Project Director (GSC) HESCO HYDERABAD before bid closing time, original bank receipt should be attached with original CDR/Bank Guarantee of Bid security.
- c. The prospective bidder shall submit Rs: 3.6 Million as Bid Security for each bid in the office of Project Director (GSC) HESCOHYDERABAD in the form of a CDR/ Bank Guarantee (Original sealed Copy) from any scheduled bank of Pakistan, in favor of Project Director (GSC), HESCOHYDERABAD, before bid closing time, failing which the e-bid shall be considered 'non-responsive' and rejected.

- g. All the information and documents provided by the bidder must be based on facts beyond any doubt. Any misrepresentation, false statement or fake document found in the proposal at any stage, would lead to debarment / blacklisting of the Firm. The matter shall also be reported to the Pakistan Engineering Council (PEC) for cancellation of registration / license of the firm.
- h. The successful bidder will have to submit 10% of the contract price as performance security in shape of CDR/Bank guarantee from any schedule bank of Pakistan.
- i. HESCO reserves the rights regarding rejection of tenders as defined in clauses all the e-bids as per clause-33 (1) PPRA rule 2004.

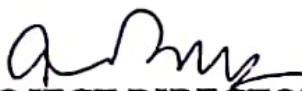
