

1. Application for pre-qualification of contractors / firms are invited by CMES (Army) Rawalpindi-II for pre-qualification and issue of the tenders for the fol works:-

Name of works:- **Const / Repair / Minor / Maint / Provn / TC / DC of Misc Buildings / Bazar Supply of B&R and E&M items in AOR of CMES (A) Rwp-II**

2. The contractors are required to submit their applications for issuance of tender documents alongwith their complete credentials as shown at serial 8. The application shall be scrutinized and the tender documents will only be issued to the firm who have sufficient experience in the relevant field and satisfy other special conditions required for the job and area. Tenders will only be issued to the scrutinized contractors. The tender must be received in the accepting officer by **1130 hrs** on **24 Jun 2025** and will be opened at **1200 hrs** on the same date.

NOTE: Contractors shall provide certificate that they are not involved in any type of litigation with Government Department in the Court of Law and that no special report of Director of Inspection and Evaluation (E-in-C's Branch GHQ) is outstanding against them.

3. All contractors will certify in writing that they are registered with Pakistan Engineering Council (PEC) and will submit a copy of their registration. Contractors not registered with PEC are ineligible to apply.

4. Contractor born on approved list of MES in categories 'A', 'B', 'C', 'D' and also having experience of this type of works should only apply.

5. Contractors who desire may be present at the time of opening of tenders.

6. The accepting officer reserves the right to accept or reject the tender. Rejected tenders will be dealt with as per Para 33 (i) of PPRA Rules.

7. The interested parties can contact to office of the **CMES (Army) Rwp-II** for further details from **0800 to 1500** hours on all working days.
