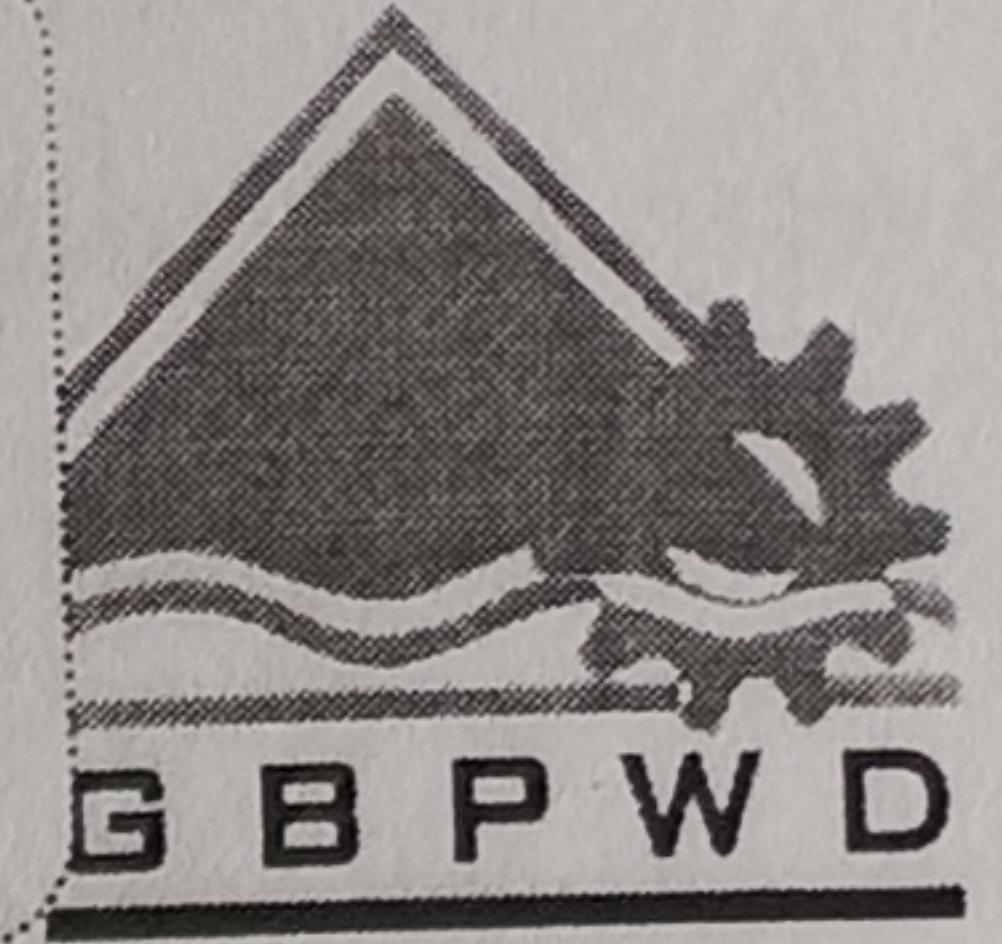

INVITATION FOR BIDS (SSOE).

1. The employer Executive Engineer B&R Division GB PWD Ghanche, invites sealed bids from eligible firms/contractors licensed with PEC in relevant category/code and renewed current financial year from GB PWD for the work. This advertisement is in consonance with PPRA Rule 2004, Rule 8, Rule 9, Rule 21, Rule 36(a), Rule 38, Rule 40, Rule 48, Rule 51.

2. A complete set of bidding documents may be obtained by any interested and eligible bidder on submission of a written application and non-refundable fee mentioned above against each work. The prospective eligible bidders may after payment of price as per Rule 19(2) of GB PPRA along with written application properly diary and dispatch numbered may obtain, personally or through an authorized representative with duly attested power of attorney for the specific work, a set of bidding documents immediately after the advertisement published in the newspapers etc. The bidders may acquire the bidding document from the office of the Executive Engineer B&R Division GB PWD Ghanche during the office hours after submitting treasury challan on account of cost of tender forms mentioned against each work showing name of contractor /work duly passed by NBP Khaplu Branch.

The said application shall be mandatorily accompanied by the following documents.

MANDATORY CONDITIONS: -

- PEC valid registration for CFY (2023-24) having relevant code and category .
- Renewal receipt GB-PWD for CFY (2023-24).
- Enlistment with procuring Agency.
- CNIC of the Prospective bidder/firm.
- Affidavit of No Litigation regarding delayed and No Blacklisting .
- The bidder must submit 01 set of bidding documents duly addressed to concerned Executive Engineer and one duplicate copy addressed relevant Chief Engineer to ensure transparency.

TERMS & CONDITIONS:-

- The bidding documents will be issued to firm/contractors subject to production of 2% bid security in shape of CDR issued by any schedule bank in Pakistan and upon production of his/her original CNIC renewal fee for CFY and Original PEC licence.
- All terms and condition of procurement process guidelines issued by Works Secretariat vide Notification No. SO-D-9(28)/2022-23/475 dated 26th January, 2023, and PEC bidding document shall be part of procurement.
- Rates quoted below 10% of the Technical Sanction shall be considered as unworkable: however.
 - The bidder quoting rates below 10% of TS shall be required to provide alongwith his bids an additional performance guarantee of 50% of the differential amount (between TS and Bid) in shape of CDR/Bar Guarantee from any schedule Bank or Guarantee bond from any AA Rating Insurance Company duly certified and vetted by the Head Office of the insurance Company.
 - In case of failure to produce the required differential amount of the bid by the bidder alongwith his documents, the bid shall be rejected and security of such bidder shall be forfeited.
- No bid shall be accepted beyond closing time as mentioned against each work.

5. In case of Gazette holiday/local holiday, tender shall be opened on next working day without further intimation.
6. The Bid validity will be 90 days after the date of opening of the bid.
7. Overwriting on bidding document is not allowed and in case of any overwriting/omission is found the bid shall be rejected.
8. Performance guarantee shall be @ 10% of the contract amount from any scheduled bank/ insurance company having AA rating.
9. Bids shall be opened in the office of the Executive Engineer B&R Division Ghanche by the procurement committee comprising of the XEN, SDO concerned, Head Estimator.
10. The contractors debarred by any Region/ division and notified by Works Secretariat shall not be eligible to participate in the bidding process .
11. The bid security of unsuccessful bidders shall not be released before the issuance of work order to the successful bidder.
12. Power of Attorney for bidding should be in Rs. 100 stamp paper in original mentioning the project name with employer stamp.
13. In case of any conflict, GBPPRA Rule 2022 shall be major rule having over riding effect on all rules concerning procurement.
