**ELIGIBILITY / EVALUATION CRITERIA:**

- a) Bidder/JV registered with Pakistan Engineering Council (PEC) having specialized code EE-04, EE-05, CE-10 & renewed upto 30<sup>th</sup> June 2025.
- b) Bidder/JV registered with Chief Engineer (D&S/S&S) NTDC Lahore.
- c) Bidder/JV registered with FBR have NTN, General Sales Tax (GST) & Punjab Revenue Authority (PRA) with "Active" status.
- d) The offered bid price must be inclusive of all taxes applicable including but not limited to Income Tax, GST (applicable in accordance to ICT Tax on Services Act & PRA Tax on services Act.)
- e) Additional 03% Bid Security of the BOQ cost shall be submitted by the bidder along-with bid if the bid cost is below the BOQ cost.
- f) Bidder/JV will provide the fresh bank statement with balance upto 50% of the BOQ cost.
- g) The bidder/JV shall furnish income tax returns for current year to FBR.
- h) Successfully completed similar nature of work within 05 years in any DISCO (**OR**) Successfully completed similar nature of work within 05 years in any Govt./Semi Govt. organization/Autonomous body/Private Housing sector and successfully handed over to concerned DISCO.
- i) Firms with Nil experience of similar nature of work can participate in the bidding process in a Joint Venture with firm holding requisite experience for a specific tender independently.

- iv) The offered bid price must be inclusive of all taxes applicable including but not limited to Income Tax, GST (applicable in accordance to ICT Tax on Services Act & PRA Tax on services Act.)
- v) The tender documents will be issued on the presentation of written request for particular work on original letter pad of the firm from the owner of the firm(s) or their authorized representative(s) having valid special power of attorney on stamp paper duly attested by the oath commissioner along-with production of original registration certificate of Pakistan Engineering Council.
- vi) Provision of experience, satisfactory performance certificate along-with copy of work order from concerned DISCO/PD is necessary.
- vii) If any fake/false information/documents submitted, the firm concerned will be liable to be blacklisted as per IESCO blacklisting policy available on IESCO website ([www.iesco.com.pk](http://www.iesco.com.pk)).
- viii) Under PPRA rule 33(1) the procuring agency (IESCO) may reject all bids or proposals at any time prior to the acceptance of a bid or proposal. The procuring agency (IESCO) shall upon request communicate to any supplier or contractor who submitted a bid or proposal, the grounds for its rejection of all bids or proposals, but is not required to justify those grounds.
