4. Call deposit receipt (CDR) @ of 5% of the total bid value from any schedule /KCB bank must be attached in favor of Director Agriculture Research Gilgit Baltistan; tender offer without call deposit will not be entertained.
5. Contractors/ Suppliers /Firms may offer only they have complete setup (own shop& workshop) with all documentary evidence.
6. Only registered firms / dealers will be eligible to participate. They must attach a copy of registration otherwise their tender will be rejected.
7. Work experience in relevant field, Firm registration certificate, CNIC of the owner, letter paid of Firm with address, vender Number & telephone Number must be attached with the bidding documents.
