- iii. Renewal receipt in Works Department GB is required for the financial year 2024-25.
- iv. Copy of National Identity card (owner of the firm).
- The firm/contractors should attach affidavit stating that no fake/tempered or bogus information contain their broacher submitted for ٧. prequalification will be blacklisted or ban will be imposed.
- Contractors/Firms having more than 03 works in hand in Communication & Works Department shall be discouraged. vi.
- All firm/contractors shall not be prequalified if already awarded work is delayed or sick without any justification/reason. A certificate from the vii. concern Executive Engineer is required to be attached.
- All interested firms/contractors are required to submit the mandatory details and provide documentary evidence of their technical and financial viii. capabilities with relevant experience in a brochure duly sign, stamp and page numbered by the authorized representative of the firm/Contractors/JV (as the case may be).
- Detailed list of works already executed or in hand by the firm duly attested by the Executive Engineer of concerned Division. ix.
- Applications of those contractors whose names are included in the list of sick projects are their name forwarded to PEC for cancellation of their license will not be considered for pre-qualification.
- TORs containing detail terms and conditions, evaluation criteria, method of procurement etc. can be obtained from aforementioned address at xi. the cost of PKR Rs.2000/- in the form of pay order in favor of the Executive Engineer B&R Nagar.
- At the time of issuance of PQ documents the firms/JVs checked thoroughly for at least 2 Nos project completed having cost of 20% of the xii. project, duly substantiated by start order, completion certificates parent department. The firm/JVs not fulfilling the conditions would not be able to obtain PQ documents for Pre-Qualification.
- List of similar nature of work already executed/in hand preference will be given to the contractor/firm who completed within stipulated. xiii.
- Application along with complete broacher showing information i/c name and address and contact No. etc. xiv.
- Bank transaction statement, line credit for the last 6 months from related to your account (Schedule bank of Pakistan) must be attached your XV. broacher.
- Only project specific power attorneys on the behalf of parent firm will be accepted, if provided on prescribed format on judicial stamp paper xvi. duly signed and attested by 1st Class Magistrate failing to this brochure will not consider for PQ Evaluation.
- Conditional Application will not be considered for pre-qualification. xvii.
- The PEC Standard document for pre-qualification will used for evaluation & assessment as per clause 3.C.2 of GB C&WD revised tender policy xviii. for financial year 2022-23.
- Only Short-listed Contractors/Firms will be called for participation in bidding process. xix.
- The procuring agency reserves the right to reject all bids or proposals at any time before accepting a bid or proposal, in accordance with Rule 36 XX. of GBPPRA Rules as amended vide SRO dated 9th September, 2022.
