Sealed tenders containing technical and financial proposal in one envelope must be submitted to undersigned on the closing date and time, which will be open by the committee on above mentioned date and time in presence of the Contractors/Suppliers of their authorized representatives at GB Board of Revenue office, Gilgit.
- 2. Contractors/Suppliers may offer only for that category of tender in which they have complete setup (Own Shop/Store/Work Shop with all documentary evidence).
- 3. The contractor/Supplier must have adequate supply/stock in Gilgit City.
- 4. Tender of each category must be offered mentioning name of category in bold letters on sealed envelope.
- 5. The bid security/Call deposit (refundable) in shape of bank draft by a schedule bank in the name of DDO GB Board of Revenue may be attached with the (Technical Documents) bidding/tender documents. Tender without call deposit from a schedule bank will not be entertained.
- 6. The bidding documents of only registered firms/dealers /suppliers/contractors will be entertained.
- 7. The rates of items if not enlisted in the "Prescribed Form" will be determined in accordance with the prevailing retail price/market rate at the time of supply.
- 8. Conditional, ambiguous and incomplete tenders will not be accepted.
- 9. Bank statement for one year, two years' work experience in relevant field, firm, registration certificate, Non-Black listed affidavit, CNIC of the owner, letter pad of firm with address Vendor Number & Telephone number must be attached with technical bidding documents duly attested.
- 10. Irrational/artificial and dubious rates offered by the firms/contractors will be rejected.
- 11. All kind of fares applicable (if any) will be inclusive in the bid price.
