## **Terms and Conditions**

- i. Firms/vendors must be General Sales Tax (GST) and Income Tax (NTN) registered with FBR and must be active for sales tax and income tax.
- ii. Bids must be submitted online through the e-Pak Acquisition & Disposal System (EPADS) of the PPRA. Hard copies of the bid(s) are not required to be submitted except for the bid security.
- iii. An affidavit on stamp paper of cost @ Rs.100/- must be attached with the bid indicating that the firm/vendor has never been indulged in any litigation and has never been blacklisted by any Ministry/Division/Department/Organization of the Government(s).
- iv. The pre-qualified firms shall be bound to provide services to the Pakistan Council for Science and Technology (PCST), Islamabad, during the Financial Year 2024-25.
- v. Interested firms/vendors should have their physical workshop in Islamabad/Rawalpindi for repair & maintenance including spare parts and all types of work regarding vehicles.
- vi. Interested firms/vendors will provide proof of at least 05 years of experience in a similar field with Government organizations/departments.
- vii. The intending firms/vendors must provide a list of their clientage and work order including at least 01 copy for the last five years for client(s) from Ministries/ Divisions/ Departments.
- viii. The firm/vendor shall be bound to install genuine parts of each item of the above works. In case the parts replaced were found sub-standard or second-hand, the firm(s) shall be struck off the list of the pre-qualified firms/vendors of PCST, and will be liable for further proceedings under PP Rules and Regulations.
- ix. The pre-qualified firms/vendors shall be bound to return the replaced/old spare items and shall be bound to give a warranty for each item replaced or repaired. If the same defect arises again during the warranty period, the firm/vendor shall be responsible for replacing it free of cost.
- x. The successful bidder(s) must take the item for repair on his own if repair is required at the bidder's workshop. The item shall be returned to PCST at his own risk and cost.

- xi. The pre-qualified firms/vendors that do not respond to the PCST call for quotation for three consecutive times, shall be excluded from the list of pre-qualified firms.
- xii. If pre-qualified firms/vendors fall short of three firms/vendors, new firms/vendors can be added through additional pre-qualification as per PP Rules 2004.
- xiii. While submitting rates the firm/vendor should include/indicate all applicable taxes. In case taxes e.g. GST are not mentioned in the rates, it will be assumed that the rates are inclusive of all taxes.
- xiv. The procuring agency (PCST) reserves the right to accept or reject any or all bids/ proposals in accordance with PP Rule No.33 of 2004 (as amended from time to time).
- xv. The tender evaluation proforma at **Annexure-I** needs to be filled, signed, and stamped by each participating firm/vendor for submission.
- xvi. In case of submission of any false information/documents and any deficiency found in deliverables even after pre-qualification, the bid security will be forfeited and the firm/vendor would also be disqualified/blacklisted.
- xvii. The procuring agency observes the highest standard of ethics during procurement and execution of such contracts. The bid will be rejected even after pre-qualification if the firm is found engaged in fraudulent practices in competing for the contract in question shall be dealt with as per PP Rules 2004.
