The Offers, prepared in accordance with the instructions given in the Auction Document, must be submitted in the Committee Room of Sir Syed Hall, Block No. 24, AIOU Main Campus, Sector H-8, Islamabad, by or before **November 15, 2024 at 1030 PST** which shall be opened same day at same place **at 1100 hours PST** in the presence of the representatives of the Offerors who shall choose to be present.

No Offeror shall be allowed to fill the Offer within the University's premises. Also, only one representative of an Offeror shall be allowed to enter the premises where the offers' submission & opening shall take place.

In case of submission of Offers through courier, the same must reach the Directorate of Purchase & Stores one day before the due date of submission of Offers.

An Offer received after the due date and time, either by hand or through courier, shall not be entertained in any case. Electronic submission is not allowed.

Auction shall be conducted through **Single Stage-One Envelope** bidding procedure, pursuant to Rule 36(a) of Public Procurement Rules 2004 (amended from time to time) and is open to all potential Offerors. **The condemned material shall be disposed-off as per "Schedule of Lifting" mentioned in Auction Document.** 

The successful Offeror(s) shall have to bear all the applicable taxes related to the auction process.

This Auction Notice is only an invitation to an offer and the University reserves the right to accept or reject all offers at any time pursuant to Rule 33 of Public Procurement Rules 2004 (amended from time to time).
