Applications are invited by the CMES (Navy) COMLOG Karachi upto **20 Mar 2025** by **1500 Hrs** for pre-qualification of contractors / firms and tender will be issued on **21 Mar 2025** against the following works under GE (Navy) Logistics in the light of Clause-1'3, 15 and 16 of PPRA Rules-2004:-

4. The contractors will furnish personnel (skilled / unskilled), Machinery / equipment, Bank statement, General Sales Tax (GST) Registration, NTN Certification.

5. Firms / Contractors not registered with Pakistan Engineering Council (Renewal of Registration for the year 2020-2021) will not be considered for issuance of tender documents.

6. Contractors **NOT BORNE** on MES approved list of contractors or **THOSE SUSPENDED** from the approved list MES contractors due to non-depositing enhanced amount of standing security will deposit earnest money equal to 2% of the estimated cost of bid in the form of FDR/ CDR etc, duly pledged in the name of CMES (Navy) COMLOG Karachi. This amount is refundable; if the contractors are not pre-qualified of they do not secure the tender / contract.

7. Application will be scrutinized and tenders will be issued to the prequalified firms / contractor. The tenders are required to be received in **CMES (Navy) COMLOG Karachi** by **1130 hours** on **28 Mar 2025** and will be opened on **28 Mar 2025** at **1200 hours**.

8. Contractors who desire; may witness the opening of tenders.
