Expression of Interest (EOI)

for

Establishment of Integrated Solid Waste Management System in Lahore Cantonment Board on Public Private Partnership Model

Lahore Cantonment Board (LCB) aims at providing high quality services for its residents ensuring a decent living place to live in and to leave a sustainable world for future generations. LCB intends to invite Expression of Interest (**EOI**) for shortlisting of reputed, experienced and registered firms/consortia/ or joint ventures for the establishment of Integrated Solid Waste Management System which includes but not limited to waste collection, transportation and disposal through state of art recycling facility.

The interested parties having experience in establishment and operations of integrated waste management project including establishment and operations of municipal waste sorting and recycling facility are requested to submit their EOI document as per rule 15 of PPRA rules, 2004.

A. Scope of work

The contractor shall be responsible for following works

- Management of operations related to waste collection and transportation operations through maximum door to door collection in residential and commercial areas.
- b. Cleaning of roads, nullahs, open areas, and removal of horticulture waste, dead animals, and debris in areas of operations.
- c. Management of transfer stations, transportation of waste to recycling facility and disposal of residual waste.
- d. Establishment of waste sorting and recycling facility at its own cost and transfer of all assets to procuring agency after completion of contract period.
- e. Provision of equipment, machinery and labor to ensure above mentioned activities
- f. The contractor shall design, built and operate the waste recycling facility at its own risk and cost.

B. Evaluation Criterion

LCB shall scrutinize the submitted EOI documents from private sector having documentary proof on following

- a. 10 years of relevant experience and past performance;
- b. Proof of relevant experience (conformation from clients)
- c. Capabilities with respect to personnel, equipment, and plant with focus on municipal solid waste recycling and disposal;
- d. Financial position

- e. Appropriate managerial capability; and
- f. Proposed PPP technical and financial model
- g. Shortlisted companies / consortia will be called for project presentation
- h. Proof of relevant experience with confirmation from clients

c. Submission and Issuance of Bidding Documents

- a. Closing date for submission of EOI document to reach in the office of Lahore Cantonment Board on or before <u>24-04-2024</u> at 1.00 pm and shall be opened on the same day at 2.00 pm in the presence of contractors or their authorized representatives who happened to present at that time. EOI document received late will not be entertained
- b. Shortlisted companies / consortia will be asked to submit the technical and financial proposals as per PPRA Rules.

D. General Instructions

- a. EOI documents shall be accompanied with company profile, registration certificates with Registrar of Firms / SECP, registration with income tax departments, and other relevant documents mentioned in the advertisement
- b. The applicant(s) shall provide affidavits for non-blacklisting, no-financial
 / legal conflict with government / private sector, correctness of information and all documents attached are authentic
- c. In case of consortium, applicants shall provide a consortium agreement clearly mentioning the roles, responsibilities of each partner. One company could not be a part of more than one consortium

d. Any information required from LCB shall be communicated within 7 days of issuance of advertisement
