- 04. Constructor/firm should provide 2% bid security as mentioned in shape of deposit at call, in the name of Executive Engineer B&R Division GB PWD Shigar from any schedule bank of Pakistan.
- 05. The contractors debarred by any Region/Division and notified by Works Secretariat shall not be eligible to participate in the bidding process in all regions.
- 06. Conditional bid shall not be accepted to the department.
- 07. Rates quoted below 10% of the Technical Sanction shall be considered as unworkable; however, The bidder quoting rates below 10% of TS shall be required to provide along-with his bids an additional performance guarantee of 50% of the differential amount (between TS and Bid) in shape of CDR/Bank Guarantee from any schedule Bank or Guarantee bond from any AA Rating Insurance Company duly certified/vetted by the Head office of the Insurance Company.
