TERMS & CONDITIONS:

1. Interested firms/bidders may purchase the bidding documents cash payment of Rs. 4,000/- on written request of original company letter pad accompanied with copy of CNIC, Income Tax registration certificate as active payer.
2. Technical & Financial bids are to be submitted at the address mentioned below on 25/04/2024 upto 11:00 am. The envelope containing Technical Bid shall be opened on the same date at 11:30 hrs.
3. Bidding documents will be issued to eligible firms based on their written application which must be accompanied with bid security @ 04% of the NIT amount in shape of deposit at Call/CDR from any schedule Bank of Pakistan in favour of "Executive Engineer, Central Civil Division, Pak. PWD, Abbottabad". The aforesaid CDR must have a date of issuance falling after the date of advertisement of this NIT in print/electronic media
4. "Single stage, two envelops" bidding procedure shall be adopted. Envelopes containing technical information of bids must be clearly marked as "Technical Bid" and envelope containing the bided price must be clearly marked as "Financial Bid".
5. In the first instance, the "Technical Proposal" shall be opened and the envelope marked as "Financial Proposal" shall be retained unopened in the custody of the procuring agency.
6. During the technical evaluation, no amendments in the technical proposal shall be permitted.
7. After the evaluation and approval of the technical proposal, the procuring agency shall open in the presence of intending bidders, the financial proposal of the technically accepted bids, at time, date and venue announced and communicated to the bidders in advance, within the bid validity period.
8. The financial bids found technically non-responsive shall be returned un-opened to respective bidders.
9. Tender will be issued to the firm who has completed at least one work of similar nature and similar amount or more, during last 05 years, duly authenticated by attested copy of work order and completion certificate issued by concerned executing agency and must be provided with application.
10. No tender will be sold by post/telephonically or on the date of opening of tender. In case of public holiday, the sale and opening will be changed to next working day. All the applicable federal/provincial and local taxes must be considered while preparing the financial proposal and are required to be built in the quoted rates. The bidders, providing fake, false and forged information shall be liable to disqualification.
11. Partial, incomplete and conditional bid will not be entertained.
