- Preferably Enlisted with MES in Cat A. In case of non-enlisted firms, 2% bid security will be provided (Refundable).
- No Special report of DI&E & no outstanding DI&E recoveries.

06. Tender will be issued to Pre-qualified firms / contractors and are required to be received in HQ DW & CE (PAF) Chakiala at 1130 hours on **20 May, 2025** and will be opened on the same date at 1200 hours.
