- Procurement will be carried out by adopting the "SINGLE STAGE - TWO ENVELOPES" procedure. The bid shall comprise a single package containing two separate envelopes. Each envelope shall contain separately the "TECHNICAL PROPOSAL" and the "FINANCIAL PROPOSAL". The envelopes shall be marked as "TECHNICAL PROPOSAL" and "FINANCIAL PROPOSAL" in bold and legible letters to avoid confusion. The Proposal complete in all respects, in accordance with the instructions provided in the Tender document, in sealed envelopes should reach on or before **Tuesday, the 24th June, 2025 up to 11:00 am** in the National Assembly Secretariat, Islamabad. Bank draft/pay order shall be attached with TECHNICAL PROPOSAL.

3. The technical proposals shall be opened on the same day at **11:30 am**, at Parliament House, Islamabad, whereas the financial proposals of the technically qualified bidders shall be opened after finalization of technical evaluation. Other details are provided in the Tender Document.
4. Bidders are required to submit their proposals strictly in accordance with Instructions as per the Tender Document.
5. Proposals duly signed, stamped and numbered must be prepared in hard book binding form to deny the possibility of addition or removal of page(s).
6. Earnest Money/Bid Security amounting to **Rs. 200,000/-** in shape of bank draft/pay order (Refundable) in Favor of National Assembly Secretariat, Islamabad must be attached with technical proposal in a separate envelope, failing which tender will not be accepted.
7. The most advantageous bid shall be accepted.
8. The firm will provide standard warranty of the equipment/accessories.
9. The quantity of all of the equipment mentioned above may increase or decrease.
10. All the applicable taxes and duties etc., must be considered while preparing the financial proposals. All these taxes are required to be built-in in the quoted rates and GST to be mentioned separately.

2. Interested firms are requested to submit their offer in the specified Performa following single stage two envelope procedure, i.e., submission of tender documents along with technical proposals and financial bid in separate envelopes.

3. The bid must be submitted by the specified date and time; late submissions will not be entertained.


4. The bidder must handle installation, configuration, and testing of the equipment. A completion certificate will only be issued after successful testing.

5. The bidder must ensure there is no conflict of interest in the submission of the bid.

6. The quoted prices should be inclusive of all applicable taxes and duties.

7. The financial proposal must include detailed pricing for all items and services, broken down by unit cost, total cost, and applicable taxes. No conditional or incomplete bids will be entertained.

8. The financial proposal will only be considered if the technical proposal is compliant with the following mandatory requirements.

1. General Terms & Conditions

- 1.1 The firm shall supply & install the items at the National Assembly Secretariat at its own cost.
- 1.2 The incomplete or conditional tenders would not be accepted and are liable to be rejected.
- 1.3 The selected Firm will have to ensure fast & timely delivery of the requisite equipment to the National Assembly Secretariat immediately after issuance of purchase order.
- 1.4 In case the selected Firm fails to deliver the required equipment within time or is unable to supply the equipment as per specifications, the letter of award / contract shall be terminated, and Earnest money/bid security of the Firm shall be forfeited.
- 1.5 The bid along with the written consent of the bidder for acceptance of the award of contract will be binding.
- 1.6 The successful Firm shall be issued a letter of award/purchase order, which on acceptance by the firm in writing, shall constitute to be a formal contract.
- 1.7 The National Assembly Secretariat reserves the right to increase or decrease the quantity of Tender Items as well to accept or reject any or all the tenders as per Public Procurement Rules 2004 as amended from time to time and the

firms are allowed to submit their bids for each individual item or all items as the case may be.

2. **Tender Price Quote**

- 2.1 Provision for all taxes including (GST) shall be included in the tender price.
- 2.2 No revision of rates will be admissible during the period of contract.
- 2.3 Price should be inclusive of all government applicable taxes.
- 2.4 Rate should be quoted in Pak Rupees.

3. **Tender Security**

- 3.1 The Firm shall furnish Earnest money/Bid Security amounting to **Rs. 200,000/-** (refundable) after the expiry of Warranty period in form of Bank Draft/Pay Order issued by a scheduled bank in favour of the National Assembly Secretariat along with their bid must be enclosed. The bid security should be sealed in a separate envelop with duly marked **“Bid Security”**.
- 3.2 Any bid not accompanied by an acceptable earnest money/bid security shall be rejected by the National Assembly Secretariat and the bidder would be considered non-responsive.
- 3.3 The earnest money/bid security of un-successful bidders will be returned after the issuance of work order to the successful bidder.

4. **Submission of Tenders**

- 4.1 The bid shall contain Instructions to bidders, general terms and conditions (Annex I & II) duly filled in and signed for having accepted the General, Special terms and conditions, Financial Bid (Annex III) & Earnest Money/Bid Security. The envelope containing bid shall be superscripted as **“Bid for supply of Equipment (Item Name)”**. The Bid must reach the office of the Section Officer (Procurement), on or before **24th June, 2025 at 11:00 a.m.**

5. **Tender Opening and Evaluation**

- 5.1 The National Assembly Secretariat will be opened on the same day at **11:30 a.m** in the presence of the Firms representatives who choose to attend at Parliament House, Islamabad.

5.2 The tender for which an acceptable notice of withdrawal has been received shall not be opened.

5.3 The Purchase Committee of the National Assembly Secretariat will examine Firm bids to determine whether the requisite Earnest money/tender security has been furnished. Whether documents have properly been signed and completed. At the tender opening the purchase committee will announce the tender name, written notifications and withdrawal, if any, for requisite equipment.

6. Tender Validity

6.1 Tender shall remain valid and open for acceptance up to 90 days after the date of tender opening.

6.2 In exceptional cases prior to expiry of tender validity period, the National Assembly Secretariat may ask the firms for a specified extension in the period of validity. The request and response thereto shall be made in writing. A firm agreeing to the request will neither be required nor permitted to modify his tender.

7. Format and Signing of the Tenders

7.1 Each page of tender documents shall be duly signed and stamped by the Firm before making submission.

7.2 Each Firm may submit only one tender.

7.3 No firm shall participate in the tender process for the same contract in collaboration or association with another firm, whether as a joint venture (multiple proposals under different names), subcontractor, or in any other relationship that may create a conflict of interest or compromise fair competition.

7.4 Bidders shall provide all relevant information as required vide Annexure II & III.

8. Mode of Payment

8.1 Payment will be made after receipt of the requisite supplies and invoices.

8.2 No advance payment will be made for any kind of procurement.

9. **Award of Contract**

9.1 The National Assembly Secretariat may award the contract to the firm whose tender has been determined to be substantially responsive.

9.2 The letter of award shall constitute to be a formal contract.

10. **National Assembly Secretariat Right to accept or reject any or all Tenders.**

10.1 The National Assembly Secretariat reserves the right to accept or reject any or all tenders or any part of the bid (in case the bidding firm submitted proposal covering multiple products) at any time prior to the award of contract as per Public Procurement Rules 2004 (as amended from time to time).

11. **Signing of Agreement**

11.1 Acceptance of the Letter of Award: Once the National Assembly Secretariat issues the Letter of Award to the successful bidder, the firm must formally accept the award within 7 days of receipt of the letter of award. The successful tender shall sign and return the letter of award through a cover letter addressed to the National Assembly Secretariat. This acceptance signifies the firm's agreement to all the terms, conditions, and obligations stated in the tender document and the Letter of Award.

11.2 Submission of Signed Documents: The firm must return a duly signed and stamped copy of the acceptance letter, acknowledging the receipt and acceptance of the award. This acceptance letter must be accompanied by a cover letter on the firm's official letterhead, confirming their readiness to proceed with the contract.

11.3 Formation of the Contract: The combination of the Letter of Award, the firm's signed acceptance, and the accompanying cover letter will together form the formal contract agreement between the two parties (the National Assembly Secretariat and the firm). This document will act as the legal foundation governing the relationship, roles, responsibilities, and deliverables of both parties.

11.4 Once this agreement is signed, both parties are legally bound to fulfill their respective obligations as outlined in the tender and agreement. Following the signing of the agreement, the firm can proceed with the project according to the terms specified, including timelines, deliverables, and quality standards.

12. Subletting

12.1 The successful tender shall not sublet the contract.

13. Suspension and Termination

13.1 The National Assembly Secretariat reserves the right to suspend the execution of any or all terms and conditions of the contract. The suspension will be communicated to the firm through a written notice issued at least one week in advance. This clause ensures that the Secretariat can pause the project if needed, such as due to unforeseen circumstances, non-performance, or a change in requirements.

13.2 In the event of a dispute between the Secretariat and the firm, the decision of the National Assembly Secretariat shall be final and binding. This emphasizes that the Secretariat has the authority to make the ultimate determination on matters of disagreement, ensuring timely resolution without external delays.

13.3 The laws of Pakistan will govern all conditions, terms, and disputes related to the agreement. This means any legal interpretation, enforcement, or resolution will adhere to Pakistani legal frameworks and courts. It establishes the legal jurisdiction under which the contract operates, ensuring compliance with national laws.

13.4 The firm will be disqualified on the basis of the following criteria:

- i. Non-submission of bid security.
- ii. Failure to meet eligibility or technical compliance requirements.
- iii. Misrepresentation of facts or submission of falsified documents.
- iv. Blacklisting by any government or private entity.
- v. Non-compliance with delivery timelines or warranty conditions.
