# TERMS & CONDITIONS OF AUCTION.

- 1. Auction against item-1 to 6 above will be conducted at Jhelum Railway Station at 10:00 a.m on 09.06.2025. Likewise auction against item-7 to 23 above will be conducted at Malakwal Railway Station at 10:00 a.m on 10.06.2025.
- 2. Every participant will deposit Rs.5,000/- (non-refundable) as participation fee and photo copy of CNIC with auction committee before start of the auction. The auction will be conducted by the Assistant Engineer, Pakistan Railways, Jhelum & Malakwal in their respective jurisdiction along
- 3. with representative of the Divisional Accounts Officer, Pakistan Railways/Rawalpindi.
- 4. Earnest money in shape of CDR will be equal to 2% of the offered bids in F/O Divisional Accounts Officer, Pakistan Railways, Rawalpindi with the intending bidders will have to deposit in advance with the auction committee at least one hour before the start of auction/bidding. No cash amount in this regard at spot will be entertained/receive d for auction.

- 5. The highest bidder will have to deposit 50% of the total bid money with auctioning committee at the sport and balance amount within 10 days of acceptance of the highest bid by the Competent Authority. Earnest money of the highest bidder will be adjusted with 50% of the highest offered bid by the auction committee. Earnest money of the unsuccessful bidders will be returned after the completion of auction proceedings.
- 6. The building for dismantling and removal of auctioned material will be handed over to the successful bidder after sanction of competent authority and deposit of 10% amount of the highest bid as security money in advance and observing all the legal formalities as well as after signing of the agreement, as per Railway Policy. Failure to deposit the remaining 50% bid money within the stipulated time could entail forfeiture of 50% bid money in favour of Pakistan Railway without issuance of any notice and the building material in question will be put to re-auction.
- 7. The highest bidder will not sub-let/transfer his accepted bid to any other person & after the demolish of building, auctioned material comprising of bricks & brick bats will be disposed off with the due expedition & site will be cleared within the stipulated completion period of one month, which will not be extended in any case.
- 8. The successful bidder will make all arrangements necessary to carry out the work as required by him at his own expense by obtaining prior approval of the competent authority.
- 9. Government servant will not participate in auction whereas any Govt: Departments are authorized to take part in the action.
- 10. The defaulters and persons involved in litigation with Pakistan Railway will not be allowed to participate in bidding.
- 11. The offered bids will referred to the competent authority on recommendation of Divisional Assessment Committee whose decision will be stand last & final.
- 12. Any other allied information can be seen on any working days in Assistant Engineer, Pakistan Railway, Malakwal, Inspector of Works, Pakistan Railways, Malakwal, Sargodha & Assistant Engineer, Pakistan Railways Jhelum and Inspector of Works P.R. Jhelum
- 13. The Railway administration may reject all bids at any time prior to the acceptance of a bid. The Railway administration shall upon request communicate to any contractor who submitted a bid, the ground for its rejection of all bids.
