- iv. Items should required to be delivered/provided & fixed/ repaired and carried out building repair work at various district after issuance of Supply Order from Inspector General Prisons Department GB, Gilgit
- v. The bidder should required to be attached one year bank statement near to 50 Lac Transaction with current balance of Rs. 5 lac.
