## REQUEST FOR PROPOSAL Hiring of Services For Collection of Contribution and Disbursement of Pension

Employees' Old Age Benefits Institution (EOBI) is an autonomous organization working under the Human Resource Division of the Ministry of Overseas Pakistanis and Human Resources, Government of Pakistan, invites sealed proposals from reputable local public sector and private sector banks for Provision of Cash Management Services For Collection of Contribution and Disbursement of Pension Across Pakistan through customized and professionally designed mechanism for a period of 05 years and extendable for further 05 years with mutual consent. Bidding will be conducted under **National Competitive Bidding pursuant to Rule 36(b) of PPR- 2004 "Single stage two envelope procedure"** and is open to all eligible Bidders as defined in the Public Procurement Rules 2004 that meet the following minimum qualification criteria:

1. Should be a registered Banking company as commercial bank with State Bank of Pakistan.
2. An active taxpayers list of FBR and registered with the provincial tax authorities:
3. Has submitted bid for complete requirement and with relevant bid security.
4. Has not been blacklisted by any of Provincial or Federal Government Department, anywhere in Pakistan.
5. Bank/Banking Company must have an established digital footprint in Pakistan and must have its fully functional mobile application.
6. Bank/Banking Company shall expressly convey its willingness to exchange data by consuming EOBI designed services for both pension disbursement and contribution collection;
7. Long term rating of A+ latest position issued by the State Bank of Pakistan.
8. Minimum 600 active branches with 800 ATMs located in all the major districts of Pakistan.
9. Agent network in districts where no branches exist.

Bid documents shall be available from the date of publication of tender notice in the newspapers from the below mentioned address, on production of Rs. 5,000/- Pay Order (non-refundable) drawn on any commercial bank in favor of "EMPLOYEES' OLD-AGE BENEFITS INSTITUTION, HEAD OFFICE, KARACHI". Financial Bid shall be opened after evaluation of technical bids for which bidders will be informed. All bids are to be accompanied with a "BID SECURITY" pay order of Rs.1,000,000/= (Rupees One Million only) drawn in favor of "EMPLOYEES' OLD-AGE BENEFITS INSTITUTION, HEAD OFFICE, KARACHI".
