- 3. The tender shall be cast electronically on or before 21/08/ 2024 upto 12:30 pm on the website (<a href="https://etender.mlc.gov.pk">https://etender.mlc.gov.pk</a>) and shall be opened on the same day at 02:30 pm in the presence of tenderer or their authorized representative, who may like to be present.
- 4. The bidder shall submit through courier / contractor representative 02% bid security sealed in envelope of the estimated cost in the shape of call deposit (original) from scheduled bank before closing date and time.
- 5. Conditional tender and tender without call deposit shall not be entertained.
- 6. Rates shall be quoted on above or below the MES Schedule of rates, 2021 (amended from time to time).
- 7. Cantt Board Multan reserves the rights to reject any one or all tenders after assigning reasons as envisaged in PPRA Rules 2004.
- 8. In case if the lowest bid is less than reasonable rates, the lowest bidder shall have to deposit standing security (refundable after successful completion of the work) reasonable amount decided by the undersigned in the shape of Call Deposit within 07 days. In case of failure the already deposited 10% earnest money shall be forfeited and bid will be cancelled.
- 9. Cantonment Board Multan shall not supply any kind of material and machinery to the contractor.
- 10. The successful contractors / firms will complete all material / lab tests before processing of bill at their own expenses.
