3. The tender documents must reach at office of the undersigned on or before the dates and times mentioned above. Tender documents will be opened on the same day as schedule given above in presence of Contractor of authorized representatives.

GENERAL TERMS AND CONDITIONS:

- i. Earnest money as mentioned above must be attached with the tender documents in form of demand draft/pay order in the name of DDO/DFO Darel-Tangir from any schedule bank.
- ii. Tenders with incomplete supporting documents shall not be accepted, and furnishing incorrect information shall be liable to legal action.
- iii. An affidavit on stamp paper of Rs.100/- must be accompanied with the tender documents to the effect that the bidder has never been blacklisted by any Government/ Semi-Government Organization /PPRA.
- iv. The firm/Contractor winning the bid shall be bound to supply the items to this Office till 30th June, 2024.
- v. The tender shall be considered item mentioned and firm shall be bound to supply/provide goods/ services at rates quoted in tender during the financial year 2024-25.
- vi. Firms quoting inappropriate rates with respect to market rates, to bring itself / himself lower shall not be considered.
- vii. Firms. Contractors are required to fill all boxes with appropriate market rates and no box shall remain unfilled.

- viii. The Contractor must have his own shop/workshop to participate in the tender. Firm/ Contractor must have at least Ten (10) years' experience for categories at "A" with at least five (05) year bank statement must be attached and can only participate in tender and attached with tender documents.
