Bidders must submit their bids through E-Pak Acquisition & Disposal System (EPADS). Bid must be accompanied by original copy of Bid Security in the form of CDR/Pay Order, in the name of Divisional Accounts Officer, Pakistan Railways, Sukkur amounting as mentioned below, alongwith other necessary documents as stated in bidding documents. Bids must be uploaded on EPADS before 11:00 hours.

However, the Bid Document uploaded from EPADS properly filled in, and Original CDR (for upload on EPADS/E-process) must be submit in the office the Divisional Accounts Officer, Pakistan Railways, Sukkur before 11:00 hours. The bids will be opened/E-opend at 11:30 hours on 24-01-2025 through EPADS in the presence of the representatives of the firms who want to witness.
