

## SBP Banking Services Corporation INVITATION TO BIDS

Invitation No. GSU (PROC)/ 166564 / Cash Trollies / 2024-25 Date: 22 Jan 2025

- 1. This Invitation to Bids follows the Procurement Advertisement (PA) No. GSU (PROC)/166564/Cash Trollies / 2024-25 for the procurement of "Supply & Delivery of Cash Trollies at SBP Banking Services Corporation (SBP BSC) Multan".
- 2. The SBP BSC Multan has reserved the funds for the procurement planned during the financial year 2024-25. It is intended that part of the proceeds of the fund will be used to cover eligible payment under the contract for the procurement.
- **3.** SBP BSC Multan now invites electronic bids from the suppliers/ contractors'/ service providers, who are registered with PPRA for E-Procurement on "e-Pak Acquisition and Disposal system (EPADS)" and meet the following eligibility criteria:
  - a. Bidder must show proof of supply of custom-made cash Trollies to at least (01) customer in Pakistan during any of the last 05 years;
  - b. Bidder must have Annual Sales Volume/Gross Turnover of at least three (3) million rupees, in any of last three (03) financial years;
  - c. Bidder must be registered with relevant tax authorities and should appear on active taxpayer list of Federal Board of Revenue.
  - *d.* Bidder should not be in litigation with and / or blacklisted by any client / customer and not on sanction list of NACTA.
- 4. The bidding shall be conducted in line with the Single Stage One Envelope Procedure of the Public Procurement Rules 2004 and any Regulations, Regulatory Guides, Procurement Guidelines or Instructions issued by the Authority (from time to time) and is open to all potential bidders.
- **5.** All bids must be accompanied by a Bid Securing Declaration in the format provided in the Bidding Documents. The prospective bidders shall upload scanned copy of Bid Securing Declaration on EPADS. Original Bid Securing Declaration must be submitted to the procuring agency on or before the closing time of bid submission failing which the bid shall be rejected.

- 7. The electronic bid s, must be submitted by using EPADS on or before 25-Feb-25 11:00 AM. Manual bids, shall not be accepted. Electronic Bids will be opened by using EPADS publicly on the same day on 25-Feb-25 11:30 AM at Meeting Room, 3rd Floor, SBP Banking Services Corporation, Multan.
- 8. In case the bid opening date falls on a public holiday, the bids will be opened on the next working day at the same time and on the same venue.
