The General condition will be as under:

- 1. Interested bidders can submit their bids online through E-Tender Portal of ML&C Dept. (http://etender.mlc.gov.pk)
- 2. Contractors having valid PEC certificate Category C-6, NTN, STRN are eligible to apply.
- 3. The cutoff time for submission of online bids will be 12:00 hrs dated <u>21</u>/02/2025 and shall be opened on same day at 14:30 hrs electronically on the portal. The contractors will be able to see the comparative statement online.
- 4. E-tenders without attachment of call deposit / bid bond in favor of the undersigned equal to the earnest money will be rejected.
- 5. The successful contractor shall enter into a prescribed agreement (at his own cost on non-judicial stamp paper) with CB Lahore within 07 days after issuance of acceptance letter.
- 6. The Cantonment Board / Executive Officer reserve the right to reject the tender as per PPRA's Rule 33(1) due to any reason thereof. (prior to approval)
- 7. The bid security/earnest money of successful bidder will be refunded after expiry of defect liability period i.e. 01 year after completion of work OR successful completion of audit which ever later.
- 8. The issuance of work order shall be subject to approval from the Board
- 9. The validity of quoted rates shall be for 180 days as per PPRA / PEC Rules
- 10. The CDR's / Bid Security / earnest money 2% shall be uploaded by the bidders. However, lowest bidder shall also deposit the said instrument (in original) in LCB office within 03 working days from the date of opening. In case of failure the bid shall not be considered and the bidder shall be liable to face the consequences of all legal action including blacklisting as per PPRA Rules.
- 11. Any information regarding the e-tender can be obtained from the office of undersigned during office hours. Furthermore, guidance tutorial has been uploaded on the portal.
- 12. Any tool/machinery kind of store/mobilization advance for execution of job will not be provided by LCB.
