## Terms and Conditions.

- The bidding shall be conducted online through E-bidding system. Tender form and BOQ can be filled online and downloaded from the official website of ML&C Department i.e. (https://etender.mlc.gov.pk).
- E-bidding shall be done on above / below percentage of MES Schedule of Rates 2021 in BOQ, -All bidders are required to have valid registration / renewed with PEC for the year 2024.
- All bidders are required to have NTN number and evidence of Active Tax Payer on ATL of FBR for income tax and Sales Tax.
- 4. All bidders are required to submit financial turnover / Bank Statement for last 4 years.
- 5. All bidders are required to submit their Income tax returns for last three years.
- All bidders are required to submit list of projects of similar nature completed or in hand for last 05 years.
- All bidders are required to submit detail of Tools / Plant / Machinery.
- 8. The tender shall be cast electronically on or before 28/02/2025 up to 12:30 pm on the website (<a href="https://etender.mlc.gov.pk">https://etender.mlc.gov.pk</a>) and shall be opened on the same day at 02:30 pm in the presence of tenderer or their authorized representative, who may like to be present.
- The bidder shall submit through courier / contractor representative 02% bid security sealed in envelope of the estimated cost in the shape of call deposit (original) from scheduled bank one day before closing date and time.

- All bidders are required to submit an affidavit regarding involved in any litigation history and shall not be blacklisted from any agency.
- 11. Conditional tender and tender without call deposit shall not be entertained.
- Cantonment Board Bahawalpur reserves the right to accept or reject all tenders (prior to acceptance) as per PPRA's Rules No.33 (1) due to any reason thereof.
- 13. In case if the lowest bid is less than reasonable rates, the lowest bidder shall have to deposit 10% standing security (refundable after successful completion of the work) or reasonable amount decided by the undersigned in the shape of Call Deposit within 07 days. In case of failure the already deposited 2% earnest money shall be forfeited and bid will be cancelled.
- Cantonment Board Bahawalpur shall not supply any kind of material and machinery to the contractor.
- The successful contractors / firms will complete all material / lab tests before processing of bill at their own expenses.
- Any information regarding e-tender can be obtained from the office of the undersigned during office hours.
- 17. Payment shall be made on approved rates as per MES schedule of Rates 2021 (amended upto date) and no escalation shall be applicable.
