The **Directorate General MIS, CGA** now invites separate sealed bids from eligible Suppliers of above mentioned lots.

The bidding shall be conducted in line with the **Single stage One envelope** procedure of the Public Procurement Rules 2004 and any Regulations, Regulatory Guides, Procurement Guidelines or Instructions issued by the Authority (from time to time), and is open to all potential bidders who may submit separate bids for above lots on their choice. **SUBMISSION OF BID THROUGH EPADS IS MANDATORY. BIDDERS ARE REQUIRED TO COMPLETE THEIR REGISTRATION WELL BEFORE SUBMISSION OF THE BIDS FOR RFB-40. NO FURTHER EXTENSION IN BID WILL BE ENTERTAINED.**

4. **Pre-bid meeting** will be held on **14-05-2024 (Tuesday) at MIS Directorate, G-5/2, Islamabad**. Bids must be accompanied by a Bid Security equivalent to 2% for Sr (A) Lot 1 and 2 **DDO Project Sehla** in the form of Pay order, Bank Draft, CD-R or Bank Guarantee and for rest of the above mentioned Lots signed Bid Securing Declaration form under Section VI, be annexed with the proposals / bids as per PPRA Rules, 2004 on prescribed format given under the bidding document with **bid validity period of 120 days**. The Procuring agency shall separately award or cancel contract, or all lots in accordance with the Public Procurement Rules, 2004.

The Original Bid (Technical and Financial bid) must be submitted on E-PADS and original bid security in sealed envelope must be delivered to the undersigned at **'DIRECTOR (ADMN/FABS/PROJECT MANAGER SEHAL), Directorate General MIS/FABS, Office of the Controller General of Accounts, CGA Complex, Old Federal Bank for Cooperatives Building, Ground Floor, Sector G-5/2, Islamabad'** on or before **21.05.2024 (Tuesday) by 11:00 A.M.** Active Registration with EPAD portal of PPRA is mandatory for submission of consolidated (Technical & Financial)Bids against each Lot.

The Technical and financial bids will be opened promptly on same day **(21.05.2024)** thereafter in public and in the presence of bidders' representatives who choose to attend the bids opening meeting at the Committee Room (6th Floor), Office of the Controller General of Accounts, CGA Complex, Old Federal Bank for Cooperatives Building by 11:00 A.M. Contract award against each Lot may be awarded separately. The Competent Authority under DG MIS and Project Sehla reserves the right to accept or Cancel One or any Lot as per PPRA Rules 2004. However, in case a bidder wins more than one or all lots, single contract may be signed with the Most Advantageous bidder.
