CRITERIA FOR PRE-QUALIFICATION/EVALUATION OF REPAIR OF FUNITURE & I.T EQUIPMENT TERMS AND CONDITION

- v. The interested parties must have sound financial positions, proof may be provided.
- vi. Non-black listing certificate on affidavit may be attached with bidding documents.
- vii. Furniture workshop must have General Sales Tax Registration, National Tax Number and is on active taxpayer list (ATL) of FBR, valid documents may be attached.
- viii. The Vendors/Firms applying for Pre-Qualification will submit Quotations on demand as and when the repair of furniture & I.T equipments is required.
- ix. The Directorate of PCA (North), Islamabad reserves the right to adopt/reject wholly or
- partially any proposal or cancel the pre-qualification process altogether at any stage under PPRA Rules.
- Only Islamabad/Rawalpindi based Repair workshops are eligible to submit their proposals.

TERMS AND CONDITIONS

- i. The workshop on the panel will be bound to carry out the requisite work on immediate basis when Repair work is referred to it even in odd hours.
- Furniture Workshop shall be liable to give warranty of each item repaired. If the same defect arises again during warranty period, the firms shall be responsible to repair it free of cost.
