3. All Contractors, will certify in writing that they are registered with Pakistan Engineering Council (PEC), FBR and will submit a copy of their registration (valid PEC license, filer status with FBR and NTN Number). Contractors not registered with PEC/ FBR are ineligible to apply.

4. Contractor born on approved list of MES in categories 'A, B, C & D' and also having experience of this type should only apply.

5. Contractor who desire may be present at the time of opening of tenders.
