- 1. The firm must have Valid Registration with Pakistan Engineering Council (PEC) in **Category C-A: No Limit**, possessing **relevant codes**, having valid Income Tax Registration (NTN) & Sales Tax Registration (STRN) with FBR, and possessing qualification as per the Bidding Documents.
- 2. **Single Stage-Two Envelope (SSTE) Procedure** of Open Competitive Bidding shall be adopted in accordance with Clause 36(b) of PPRA Rules, 2004. The bid shall comprise a single package containing two separate envelopes: Each envelope shall contain separately the **Financial Proposal** and the **Technical Proposal**.

The Proposals (Technical & Financial), be prepared in accordance with the instructions provided in the bidding documents, and must be submitted on e-PADS (https://eprocure.gov.pk) through electronic means only, by 22nd August, 2024, upto 12:00 Hrs. Proposal(s) received after prescribed time and date shall be rejected.
- 7. Original Bid Security must be submitted to the below mentioned address prior to the online submission deadline of the bid. E-Tenders without submission of Bid Security in favor of FGEHA will be rejected.
- 8. Technical Proposals shall be opened on the same date at **12:30 Hrs.** Bidders will be **"Post Qualified"** on the basis of information provided with the proposals in the light of Bidding Documents. Firms who fail to qualify technically shall not be considered further.
- 9. All the applicable Federal/Provincial taxes (income tax, sales tax, etc.) must be included while preparing the Financial Proposal and are required to be built in the quoted rates and not to be mentioned separately.
- 10. Partial, incomplete and conditional bids will not be entertained.
- 11. The bidders providing fake, forged, unsubstantiated and false information shall be liable to legal actions i.e. disqualification and blacklisting.
