- Bidder / Manufacturer must have supplied 100% tender quantity of SPA, SPD & SPG grouting bolts during last 05 years.
  - Inspection and testing facility at manufacturer's place
  - The Bidder / Manufacturer are required to submit their registration for general sales tax with Punjab Revenue Authority.
  - Identity Card of Contractor / Managing Partner / Director of the firm.
  - Bidding documents will be issued only to the owner of the firm OR representative holding authority letter of the firm.
  - Income Tax Returns** for last two years.
