- National Competitive bidding (NCB) will be conducted in accordance with Single Stage One Envelope for Tenders No. 22, 23, 24, 25, & 26 and Single Stage Two Envelope Bidding Procedure for Tender No. 27 & 28. Bid must be for full tender quantity and in case of Lot, the bid must be for full Lot quantity, less quantity will not be accepted.
- Only e-Bids will be accepted, all the interested bidders are directed to apply through E-Pak Acquisition & Disposal System (EPADS) portal at <https://eprocure.gov.pk> as per procedures laid down in the regulations of PPRA. All interested bidders must register themselves at EPADS by using link <http://eprocure.gov.pk/#/supplier/registration>.
- Bidding documents can be downloaded from EPADS portal through supplier login. The bidding documents contain detailed instructions/terms & conditions and specifications, are available for registered bidders.
- Bids must be prepared in accordance with the instruction in the bidding documents and submitted on EPADS as scheduled above. Hard copy of the same bid also must be submitted in the office of Chief Engineer (Dev) PMU PESCO, Shami road, Peshawar before the bid closing time as scheduled above, failing which the bid(s) shall be considered 'non-responsive' and rejected.
- Bid validity will be **90 days** from the date of opening of tender. The Bid Security shall be valid 30 days beyond the bid validity date.
- The prospective bidder must submit Bid Security of the amount mentioned in bidding documents for each tender. The original Bid Security must be attached with the Hard Copy of the bid and the reference / Pay Order copy shall be submitted through EPADS, failing which the bid(s) shall be considered non-responsive and rejected. In Single Stage Two Envelope tender, the original bid security shall be submitted with the hard copy of the technical bid and also on EPADS.
- Tender will be opened in the office of Chief Engineer (Dev) PMU PESCO, Shami road, Peshawar on date & time mentioned above.
- The bid having conditional bids, partial, incomplete documents and not containing the original Bid Security shall be rejected.

PESCO (Peshawar Electric Supply Company) reserves all its rights regarding rejection of Tenders without providing any justification as defined in clause 33(1) of PPRA rules 2004.
