1. Bids are invited from reputed / renowned firms / companies / individuals registered with relevant food authority duly supported with documentary evidences as required in Tender documents.
2. Pay order/bank draft/banker's cheque of amount Rs. 2000/- (non-refundable) in the name of Director General PITAC, Lahore, must be submitted along with bid as Tender participation Fee.
3. Bidding will be conducted under National Competitive Bidding Procedure as per the provisions of Public Procurement Rules-36(b) **Single stage – two envelopes** procedure.
4. Bids may be submitted as per conditions set out in bidding documents electronically through Federal PPRA EPADS web portal <http://eprocare.gov.pk> before closing time & date. Manual bids shall not be accepted. The bids shall be opened on the same day at 11:30 AM.
5. Conditional bids shall not be entertained.
6. Scanned copy of Bid Security of Rs. 50,000/- in the shape of deposit at call or a bank guarantee issued by a scheduled bank in the name of Director General PITAC, Lahore be sent through EPADS, while the original Bid Security must be dispatched to the undersigned. Bid, without earnest money will be rejected.
7. The successful bidder will submit Performance Guarantee of Rs. 100,000/- (refundable), which will be retained for the whole period of contract. Performance Guarantee Rs.100,000/- will be forfeited on un satisfactory performance.
8. After the Technical evaluation, financial proposals of only technically qualified bidders/ Firms/Companies will be opened later on and date will be communicated to technically qualified bidders.
9. The bids of any bidder shall be declared non-responsive, if he is found involved in litigation with any government or semi-government department.
10. The bidders should be on active taxpayers list of FBR, valid copies of Tax Certificate(s) will be attached.
11. PITAC reserves the right to reject all bids as per rule 33 PPRA 2004.
12. Quoted rates/price shall remain valid for a period of 01 year.
13. The firm has to submit an **affidavit on Stamp Paper**, being not blacklisted from any Govt. Department.
14. Initial contract period will be for two years, extendable for another year on satisfactory performance.
15. The detailed requirements, terms & conditions are mentioned in Tender Document.
16. Further, personal convincing, recommendation or unauthorized practices for getting the Contract, will also disqualify the bidders.
