It is furthermore, informed that Bidders need to get registered at e-Web portal of e-PADS PPRA (Federal) to access the tender documents and other relevant information including electronic bid submission.

3. In this regard, Bids should be submitted electronically only through E-PADS we portal. Manual submission of bid, without e-PADS electronic bid is not acceptable. For registration and training on e-PADS or in case of any technical difficulties in using e-PADS, prospective bidder(s) may also contact Room No. 109, 1st Floor, FBC Building Sector G-5/2, Islamabad or helpline contact No. 051-111-137-237.

4. The bids prepared in accordance with the following Terms/conditions and the bidding documents must be submitted through e-PADS web portal before the **closing date 14-05-2025 at 11:00 am**. Bids will be opened on the same day at **1200 hrs** through e-PADS.

5. The **Terms and Conditions** are as under:-

- i. Tenders should accompany an Earnest Money, refundable (details below), in the shape of Bank Draft/Pay Order in the favor of Drawing & Disbursing Officer (DDO), Ministry of Commerce, Islamabad. Cheques are not acceptable.
- ii. Bids are required to be submitted item-wise clearly indicating rates including General Sale Tax (GST) in Pak-Rupees against each item.
- iii. Rates with GST will be considered and shall be valid for **Financial Year 2024-25** i.e. **01.07.2024 to 30.06.2025**.
- iv. Submission of false statement/documents as well as concealing of any information by the Bidder(s) is liable to disqualifications under rules 18 of Public Procurement Regulatory Authority (PPRA).
- v. The successful firm(s)/vendor(s)/supplier(s) shall not change/revise rates during the **CFY-2024-25** and shall be responsible for supply of the items as per approved prices failing which Security Deposit will be forfeited and the firm will be blacklisted.
- vi. Successful bidders will deliver item(s) at "A" Block, Pak Secretariat, Islamabad at their own cost.
- vii. Broken or damaged items if any by the supplier(s)/vendor(s) will be replaced free of cost.
- viii. The Competent Authority reserves the right to reject any or all of the bids.
- ix. Under Rule 36(a) of PPRA-2004, single stage two envelope procedure will be adopted.
