1. The National Highway Authority (NHA) intends to hire/ engage a Consultant (Engineering Organization/ Firm) for Consultancy Services for Feasibility Study & Detailed Design for Dualization of Road from Chistian to Chak No. 46/3R via Dahrnawala (44.5 km Approx.).
2. Proposals are invited from reputable Consultants (Engineering Organizations/ Firms):
(i) having PEC registration in relevant field with relevant experience as mentioned in the RFP and
(ii) registered with Income Tax and Sales Tax Departments and who are on Active Tax Payers list of the Federal Board of Revenue.
3. Request for Proposal (RFP) can be downloaded from NHA's website www.nha.gov.pk free of cost or the same can be purchased from the office of General Manager (P&CA), NHA-HQ, Islamabad during working hours and working days on written request of firm's letter head accompanied with pay order/demand draft amounting to Rs.1,000/- (nonrefundable) in favor of National Highway Authority.
4. Pre-Proposal Conference will be held on **2nd August, 2022 at 1100 hours** in the office of General Manager (P&CA), National Highway Authority, Islamabad. Due to COVID-19, only one authorized representative will attend the pre-proposal meeting as well as proposal opening event.
5. Procurement will be carried out by adopting "Single Stage Two Envelops" procedure. The Proposals complete in all respects, in accordance with the instructions provided in the RFP document, in sealed envelopes should reach on or before **31st August, 2022 at 1130 hours** in the office of General Manager (P&CA), National Highway Authority, 27-Mauve Area, G-9/1, Islamabad and be clearly marked "*Consultancy Services For Feasibility Study & Detailed Design for Dualization of Road from Chistian to Chak No. 46/3R via Dahrnawala (44.5 km Approx.)*".
6. Consultants are required to submit their proposals strictly in accordance to Instructions to Consultants, Data Sheet of Request for Proposal and RFP Notice. Proposals must be prepared in hard book binding form to deny the possibility of addition or removal of page(s).
7. The technical proposals shall be opened on the same day at **1200 hours**, whereas the financial proposals of the technically qualified firms shall be opened after finalization of technical evaluation. Other details are provided in the RFP.
8. All the applicable Federal, Provincial & Local taxes including GST must be considered while preparing the financial proposals. All these taxes are required to be built-in in the quoted rates including GST.
9. The Firms/ Consultants providing unsubstantiated and/or incorrect information are liable to legal action and/ or disqualification.
