1. Tender document instruction and specification can be viewed / downloaded from e-tender portal at <https://etender.mlc.gov.pk>
2. The tenderer shall submit 2% bid security of the estimated cost in the shape of call deposit and upload / attach its valid soft copy along with bid Challan and original CDR with the electronic bid Challan with electronic bid before closing date & time.
3. The tenderer is bound to electronically submit verified and genuine documents as well as call deposit, if in case his documents are found altered / fake / bogus, the Cantonment Board is at

liberty to initiate criminal proceedings by lodging FIR on the basis of forgery / fraud against the tenderer and he / his firm shall be black listed.

4. The tenders can only be submitted in electronic format through e-tender portal from date of publication in newspaper and portal, the deadline for submission of tender is 20/08/2024 at 1200 hrs, tenders shall be open on the same day at 1400 hrs in the presence of contractor or their authorized representatives, who which to be present.
5. No manual tender shall be entertained.
6. Any information regarding the e-tender can be obtained from the office of the Cantonment Board kamra during office hours. Furthermore, the contractor user manual regarding bidding has been uploaded on the e-tender portal, which can be accessed and downloaded.
7. The validity of Tender / Quotation rates shall be minimum upto 180 days as per PPRA / PEC Rules.
8. The Cantonment Board reserves the rights and may ask the analysis of the quoted rates from the concerned tenderer to determine their responsibility and workability.
9. The contractors / bidders, who quote their bids / rates more than 10% below the MES Sch. of rates 2021 / Engineers Estimate shall submit performance guarantee equal to 10% of the Estimated Cost under rule 39 of PPRA Rules 2004(refundable after successful completion of the work) in the shape of Call Deposit Receipt (CDR) within 05 days. In case of failure the already deposited 2% earnest money shall be forfeited and the tender shall be offered to 2nd lowest participant as per rules.
10. The quantum of work may increase / decrease as per PPRA Rules and lowest tendered shall be bound to execute the work on similar rates / terms & conditions.
11. Conditional / incomplete tenders / quotation wherein necessary details are missing will not be accepted.
12. Works will be executed as per availability of funds.
13. The issuance of work orders shall be subject to approval of CFA / release of grant.
14. Successful tenderer will be bound to deposit mandatory dues as already resolved by the Board and shall have to execute an agreement (at their own cost) on non-judicial stamp paper of appropriate value for faithful execution of the contract.
15. The Cantonment Board / Executive Officer reserves the right to reject all tenders as per PPRA's Rules No. 33(1) due to any reason thereof.

PROCESS FOR E-TENDERING / E-BIDDING SYSTEM

➤ CONTRACTOR REGISTRATION

○ Sing Up

- Contractor must register himself through ML&C portal (<https://entender.mlc.gov.pk>) and click on “**SignIn / SignUp**” Button for
- sign up by entering **Login ID** (must be unique), **NTN Number, Company Name, Password, Confirm Password and Mobile Number**. An OTP (One time password) will be sent to the mobile number. Enter OTP and click **SignUp** Button

○ Sing In / Log In

- Contractor can view tender after sign-in by entering credential (**login ID and Password**). Provided while sign up.

○ Contractor Profile

- Contractor must complete the contractor profile in order to participate in the in the bidding process, which includes Company Profile, Registration Details, Work History, Team Profile and Documents Attachments then submit it for approval.

➤ E-BIDDING PROCESS

○ Contractor can bid on tender only if;

- Logged in to the ML&C E-Tendering System
 - Approved / Registered contractor with Cantonment Board Kamra
 - Valid PEC Category. Code and License
- For submission of bid, contractor must provide original **CDR** 19/08/2024, before working closing hours attach scan copy of **CDR** and submit.
- After submission of the bid, contractor can view the submitted bid on the dashboard.

➤ OPENING OF THE BID

- On the day of opening of bid, contractor can view the comparative statement which shall be generated through the system.
