### AUCTION NOTICE

It is hereby notified for the information of general public that 68 different kinds of green, dead and fallen trees (Details of trees with its kind could be obtained from office during working hours) will be disposed of through open public auction scheduled to be held on **11-12-2023 at 1100 hours** in the office of the CEO (ME-Section), Jhelum Cantt. In case, auction is not conducted or low bid is received on due date the auction will be held again on **12-12-2023 at 1100 hours**. For further information regarding auction /trees checking, please contact Cantonment Board Office (ME-Section), Jhelum Cantt. The detail of terms and conditions given below:-

### CONDITIONS OF AUCTION

1. The interested persons shall have to deposit with this office Rs.50,000/- as token money before the auction alongwith valid copy of the CNIC. After auction the token money will be returned except that of the successful bidder. Without depositing of token money, no persons /contractor will be allowed to participate in the auction.
2. The highest bidder shall have to deposit 1/4<sup>th</sup> total bid money at the fall of hammer and the remaining balance amount will have to be deposited within seven (07) working days of the receipt of approval from the Competent Authority. In case the balance amount is not deposited by the successful bidder within prescribed period, the 1/4<sup>th</sup> bid money as already deposited by him will be forfeited in favour of Government and trees will be put to re-auction at his risk and cost.
3. The successful bidder shall deposit 10% of total bid money as advance Income Tax & 17% of total bid money as General Sale Tax in case of stock / dumped material at the time of depositing of balance amount and 10% of total bid money as advance Income Tax for standing trees.
4. On issuance of permit to cut /removal the material the 1/4<sup>th</sup> amount as already deposited by him will be kept as security and will be refunded to him after the trees are removed and the site is leveled without any loss to the Government/ Private property.
5. The successful bidder shall be responsible for any damage caused by him to Government/ Private property during the removal of trees and the successful bidder will have pay full amount of damage.
6. The successful bidder shall remove the trees by digging out their roots from the ground and shall restore the land to its original condition at his own expense.
7. The trees shall not be cut during night or on public holidays failing which the permit shall be cancelled and trees will be re-auctioned with/without notice to the highest bidder.
8. If the trees are not removed within prescribed period, cost of wood/ trees already deposited shall be forfeited towards Government fund and trees shall be disposed of by the Government as deemed fit without any compensation to original bidder.
9. The undersigned reserves the right to reject any or all the bids without assigning any reason before approval of the bid.



10. The security deposited by the successful bidder shall be forfeited in case of breach of any condition of auction notice.
11. The details of trees to be auctioned or any other information pertaining to the same may be obtained from the office of the Cantt Board Office, ME-Section, Jhelum Cantt during any working day before the day of auction.
12. An application for refund of amount of security would be submitted by the wood contractor promptly after disposal of the said trees otherwise deposited amount of security shall be forfeited towards Government fund, after lapse of one month.
