TERMS AND CONDITIONS

- Technical bids would be invited through EPADS.
- Quotations shall be accepted only as per Tender Document (specification). Tender Documents should to be collected from our Office (State Life Ins. Zonal Office Bahawalpur). Tender Documents Fee will be Rs. 1000/-.
- Tender will be opened in the Office of In charge (HR&A) Department / Secretary ZPC Bahawalpur Zone in the presence of the Bidders or their representatives who choice to attend.
- The Tenders received after the due date & time will not be entertained the in-time collection/submission tender will be exclusive responsibility of the bidder.
- The security guards preferably should be ex-army men (as per Tender Documents). Who will have to perform their duties in shifts (As per Tender Documents). Civil Guard should be trained.
- The submission of Professional Tax Certificate shall be mandatory for bidder.
- All rates should be mentioned inclusive of all taxes. Rates of Ex Arm Service Men and Civilian Guard should separately mention on quotation.
- All the taxes will be deducted as per Government Rules and Regulations.
- Bidders are required to submit (03%) Rs. 100000/- of their bid (refundable) being earnest money in shape of CDR/Bank Order/DD in the name of State Life Insurance Corporation of Pakistan, otherwise bid will not accepted.
- The number of Security Guards can be increase/decrease as per requirement/as and when required
- The work order will be given after signing of contract mutually (as per Tender Documents).
- Contract can be cancelled by giving one month notice period.
- The contract will be given for one year and it would be effective from the date of approval Zonal Procurement Committee. In future the said contract can be renewed and would extendable with same terms & conditions if mutually agreed by the both parties (further detail is in tender documents).
- The security company will have to provide 12 bore Repeater or equivalent weapon, Torch, Detector and Mirror to its guards (Further detail is in Tender Documents).
- Zonal Procurement Committee reserves the right to accept or reject all bids or proposal at time prior to acceptance of a bid or proposal. However, State Life on request shall communicate any contractor who submitted a bid or proposal, the grounds for its rejection of all bids proposals. The tenders shall be required to quote the rates inclusive of all taxes.
