



**TERMS AND CONDITIONS AND EVALUATION CRITERIA**  
**FOR SUPPLY OF UNIFORMS**

Tender from showing details/specifications of the requisite “Uniform Articles” can be obtained from Collectorate of Customs, Gilgit Baltistan during working hours. The bids are to be submitted in sealed/ confidential cover and the same will be opened on the same day in the presence of bidders or their authorized representatives who wished to be present.

2. The quoted rates must be inclusive of all applicable duties/taxes, transportation, overhead cost etc.
3. Earnest money / bid security deposit @ five percent of the total bid price (refundable) in shape of call deposit/ pay order in favour of the DDO, Collectorate of Customs Gilgit Baltistan, Gilgit should be enclosed with the bid. Any bid which is not accompanied by the earnest money/bid security at the time of opening of bid shall be outrightly rejected.
4. The quantity of items to be purchased can be increased or decreased.
5. All items will have to be supplied strictly as per specifications mentioned in the Tender form.
6. The validity period of the bid/ rates will be applicable upto **30.06.2025** from the date of opening thereof.
7. All items will have to be supplied strictly as per specifications mentioned in the tender form within 10 days of the issuance of purchase order.
8. Detail of experience with other Government departments for similar suppliers must be provided.
9. Sample of the materials major items must be accompanied with the bid.
10. Tender will be evaluated on the basis of most advantageous bidder as Per PPRA Rules. Procuring agency may reject all bids or proposals at any time prior to the acceptance of bid or proposal. The procuring agency shall upto request communicate to by supplier or contractor who submitted a bid or proposal, the grounds for its rejection of all bids or proposals, but is not required to justify those grounds.
11. Payment will be made after receipt of all the items mentioned in work order.
12. No bid shall be entertained after given cut of date and time.
