TENDER NOTICE

- 1. The Water and Power Department Gilgit-Baltistan (the "Employer") has received a loan /credit from the Government of Gilgit-Baltistan towards the cost of Supply, Installation, Commissioning and Test Running of 3 x 1000 KW TG Set Ph III Kachura and 1 x 1000 KW TG Set Ph II Jaglote Sai, and it is intended that part of the proceeds of the loan/credit will be applied to eligible payments under the contract for the supply, installation, commissioning and test running of 04 MW turbo generating sets. Bidding is open to all eligible bidders.
- The employer invites sealed bids from eligible firms or persons licensed by the Pakistan Engineering Council in the appropriate category and code for the works. A foreign bidder is entitled to bid only in a joint venture with a Pakistani constructor in accordance with the provisions of PEC bye-laws.
- Bidders may obtain further information from, inspect at and acquire the bidding documents from the office of the employer through Executive Engineer Water & Power Division GBHEW, located near KIU.
- 4. A complete set of bidding documents may be purchased by an interested bidder on submission of a written application to the above office and upon payment of a non-refundable fee of Rs.10000/-.
- 5. All bids must be accompanied by a bid security equal to Rs.23200000/- of bid amount or an equivalent amount in a freely convertible currency from a scheduled bank of Pakistan, and must be delivered to office of the Superintending Engineer Water & Power Circle Gilgit at or before 1200 hours, on 8th July, 2024. Bids will be opened at 1230 hours on the same day, in the presence of bidders' representatives who choose to attend at the same address.
