Contractors /Firms on the date & time mentioned below, which will be opened by the Chairman Procurement Committee/Deputy Secretary (B&A), in presence of the Contractors or their authorized agents who care to attend, on 23<sup>rd</sup> July, 2024 at 11:30 AM at the office of Deputy Secretary Education (B&A) Gilgit-Baltistan:-

## **TERMS & CONDITIONS:-**

- 1. The tender rates will stand valid for Repair of Transport, Purchase of office stationery and others/miscellaneous items for the office of DDO Secretary Education GB only.
- 2. The tender/bidding document of only registered firms/dealers/suppliers/contractors shall be entertained.
- 3. The Contractor/Suppliers must be sole proprietor having his own complete setup (shop/store/workshop) containing adequate supplies in Gilgit city.
- 4. Prices offered should be for each/every item separately; partial offers shall be rejected straightaway. Conditional offers shall also be considered as non-responsive.
- 5. The Procurement Committee shall physically inspect/check the bidders Shop/Store/Workshop to satisfy itself that the same exists with adequate supplies along with technical expert/staff.
- 6. Bid Price against each item should not be unrealistically higher or unrealistically lower than the prevailing general market prices.
- 7. Incomplete bids with in-complete details (specification/strength/manufacturer etc. will be rejected.
- 8. 5% of the bid value in the form of call deposit issued by a Schedule Bank may be deposited in favor of Secretary School Education GB otherwise bids are liable to be rejected technically.
- 9. After acceptance of the bids, a separate agreement deed has to be undertaken between the bidder & procuring agency i.e. office of DDO Secretary School Education GB.
- 10. The Chairman of procurement committee reserves the rights to accept or reject in part or whole of tender.
- 11. Bidder will be selected on the basis of the rates offered and his experiences & performance in relevant field i.e. workshop/shop/store in Gilgit city & Technical experience in relevant filed.
- 12. The Company/Firms will have to submit affidavit for not have been blacklisted on legal stamp paper.
- 13. Tender process will be completed in accordance with the relevant rules of PPRA 2024.
- 14. Bidding Form/documents can be obtained from the office of the DDO Secretary School Education GB w.e.f 8<sup>th</sup> July, 2024.
- 15. Last date for submission of documents shall be 23-07-2024 (11:00 am).
