The Constructors are required to submit their applications prepared in accordance with the instructions in the prequalification documents, online through E-PADS at <http://eprocure.gov.pk> (Scanned Copy) and Original must be submitted in sealed envelope in the office of Director Engineering-I at Pakistan Housing Authority Foundation (PHA-F), located on the First Floor of Shaheed-e-Millat Secretariat, Jinnah Avenue, Blue Area, Islamabad as per the schedule date and time. Applications received after lapse of the aforementioned date and time shall not be considered.
4. Interested bidders can obtain any further clarifications from the office of Dy. Director Engg-I & IV at PHA Foundation.
5. The name and address of the constructor shall be clearly marked on the envelope.
6. Only Constructors pre-qualified under this procedure will be invited to Bids.
7. In case of any ambiguity or discrepancy between the hard and soft copies, the hard copy shall prevail.
8. No Prequalification Documents shall be available for download on the date fixed for submission.
9. In case of any unforeseen reasons, public holiday or force majeure on the submission / opening date, the Applications shall be submitted/opened on the next working day at the same place and time.
