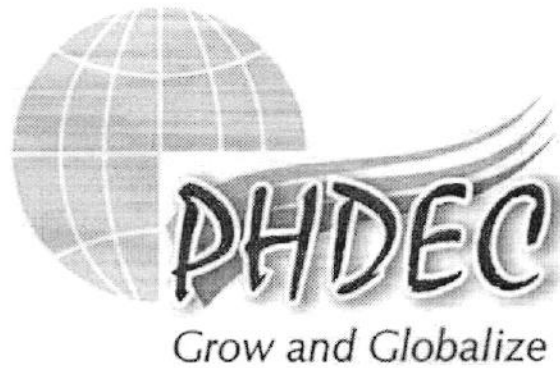

1. Introduction:

Pakistan Horticulture Development & Export Company (PHDEC) is a company registered under Section 42 of the Companies Act 2017 mandated to promote, co-ordinate and enhance the horticulture sector of Pakistan. It has always played a key role in introducing Pakistani horticultural products to high-end international markets with strategic initiatives and efforts, and has always led from the front through integrated interventions to facilitate the sub-sectors of horticulture value chains of Pakistan.

PHDEC intends to hire services of a testing assessment firm/ agency/ body to design and conduct the screening test of applicants as per the approved requirements against various posts.

2. Receipts of Bids:

Sealed bids (Technical and Financial) both in separate sealed envelope duly marked in two envelopes (one marked as Technical and one marked as Financial) should reach Asst. Manager (GA & HR), "PHDEC, Ground Floor, State Life Building No.5, Phase-II, Jinnah Avenue, Blue Area, Islamabad" latest by **21st January, 2025** before 11: 00 a.m and will be opened on the same day at 2:00 p.m

i) Technical Bid:

The technical bid shall consist of all the documents eligibility requirements and those which the bidders deem necessary as a proof of qualification/ experience and legal status.

ii) Financial Bid:

The bidder shall prepare its financial bid based on the bidding documents.

iii) Technical Evaluation:

The technical bids of the firms will be evaluated on the basis of evaluation criteria.

iv) Award of contract:

The contract shall be awarded subject to fulfillment of Rule 35 of PPRA Rules 2004.

3. Task of the Testing Agency:

- i) The Testing agency shall design the application form(s) and share the same with PHDEC for approval.

- ii) The Testing agency shall collect and evaluate the application of the candidates in conformity with relevant conditions for eligibility, relevant criteria, experience, quota, and age limits as provided by PHDEC.
- iii) Applications will further be sorted by the testing agency to conduct test at respective testing centers.
- iv) The testing agency will provide broad guideline / topic to set pattern.
- v) Final Result including the test, will be provided by the testing agency within 30 days from the date of publication of advertisement.

4. Size of Test Arrangement:

Each test will be conducted according to the prescribed requirement of arrangement at national, provincial and district level.

5. Eligibility requirements:

- i) Detailed profile of firm/agency/body along with location of its offices and their contact details.
- ii) The agency must have a national presence with established testing centers in major cities of Pakistan.
- iii) The agency must have at least 10 years of experience in conducting recruitment tests for Government or reputable private organizations including proven capacity to conduct tests for at least 5,000 candidates per cycle.
- iv) Prior experience of conducting tests for Government organizations will carry extra marks.
- v) Demonstrated capacity to undertake paper based as well as computer based tests will be critically analyzed.
- vi) The agency must be a legally registered entity with the Securities and Exchange Commission of Pakistan (SECP) or other relevant bodies.
- vii) Firm/ agency must have a valid NTN and should be on active tax payer's list of FBR and should be registered with Directorate of General Sale Tax (GST).
- viii) Relevant ISO or other certifications shall be preferred and will carry extra marks.
- ix) Firm/ agency must attach an affidavit to the effect of good track record and that it has never been black listed by any Government organization at any stage.
- x) The agency must demonstrate financial stability with audited financial statements for the last three years.
- xi) The agency must have a secure and robust system for test development, delivery, and result compilation to avoid leakage or fraud.
- xii) The timeline of recruitment mutually agreed by the parties must be strictly followed failing which, the bidder will be disqualified.
