The CDR/ earnest money upload online shall also be deposited (in original) in WCB Office (CB Care Center) on the same day prior to cut off time in shape of demand draft/ CDR/ pay order before opening of e- tender as per PPRA Rule No. 25. In case of failure the bidder shall not be qualified for bid opening and shall be liable to face the consequences of forfeiture and blacklisting for sabotaging the tendering process.
- 5. The cutoff time for submission of online bids will be 1200 hrs dated 30-05-2025 and shall be opened on same day at 1230 hrs electronically on the portal. The bidders will be able to see the comparative statement online.
- 6. The successful bidder shall enter into a prescribed agreement (at their own cost on non-judicial stamp paper) with the CB Walton within 07 days of issuance of acceptance letter.
- 7. The Cantonment Board/ Executive officer reserve the right to reject the tender as per PPRA's Rule No. 33 (1) due to any reason thereof.
- 8. The issuance of work order shall be subject to approval from Board.
