## SECTION II: INSTRUCTION TO BIDDERS (ITBs)

This Section provides information to help Bidders prepare their Bids. Information is also provided on the submission, opening, and evaluation of Bids and on the award of Contracts.

These instructions are supplemented by Bid Data Sheet in following Section III.

	A. Introduction		
1. Scope of Bid	1.1	The Procuring Agency (PA), as indicated in the <b>Bid Data Sheet</b> (BDS) invites Bids for the provision of Services as specified in the BDS and <b>Section V</b> – <b>Scope of Services</b> The successful Bidders will be expected to deliver the Services within the specified period and timeline(s) as stated in the <b>BDS</b> .	
2. Source of Funds	2.1	Source of funds is referred in Clause-2 of Invitation for Bids.	
3. Eligible Bidders	3.1	A Bidder may be natural person, company or firm or public or semi-public agency of Pakistan or any foreign country, or any combination of them with a formal existing agreement (on Judicial Papers) in the form of a joint venture, consortium, or association. In the case of a joint venture, consortium, or association, all members shall be jointly and severally liable for the execution of the Contract in accordance with the terms and conditions of the Contract. The joint venture, consortium, or association shall nominate a Lead Member as nominated in the BDS, who shall have the authority to conduct all business for and on behalf of any and all the members of the joint venture, consortium, or association during the Bidding process, and in case of award of contract, during the execution of contract. ( <i>The limit on the number of members of JV or Consortium or</i> <i>Association may be prescribed in BDS, in accordance with the guidelines</i> <i>issued by the PPRA</i> ).	
	3.2	The appointment of Lead Member in the joint venture, consortium, or association shall be confirmed by submission of a valid Power of Attorney to the Procuring Agency.	
	3.3	Verifiable copy of the agreement that forms a joint venture, consortium or association shall be required to be submitted as part of the Bid.	
	3.4	Any bid submitted by the joint venture, consortium or association shall indicate the part of proposed contract to be performed by each party and each party shall be evaluated (or post qualified if required) with respect to its contribution only, and the responsibilities of each party shall not be substantially altered without prior written approval of the Procuring Agency and in line with any instructions issued by the Authority.	
	3.5	The invitation for Bids is open to all prospective Service Provider, firms or authorized agents/dealers subject to any provisions of incorporation or licensing by the respective national

3.6	Foreign Bidders must be locally registered with the appropriate national incorporating body or the statutory body, before participating in the national/international competitive tendering with the exception of such procurements made by the foreign missions of Pakistan. For such purpose the bidder must have to initiate the registration process before the bid submission and the necessary evidence shall be submitted to the procuring agency along with their bid, however, the final award will be subject to the complete registration process.
3.7	<ul> <li>A Bidder shall not have a conflict of interest. All Bidders found to have</li> <li>a conflict of interest shall be disqualified. 	3.9	Bidders shall provide to the Procuring Agency evidence of their eligibility, proof of compliance with the necessary legal requirements to carry out the contract effectively.
	3.10	Bidders shall provide such evidence of their continued eligibility to the satisfaction of the Procuring Agency, as the Procuring Agency shall reasonably request.
	3.11	Bidders shall submit proposals relating to the nature, conditions and modalities of sub-contracting wherever the sub-contracting of any elements of the contract amounting to the more than ten (10) percent of the Bid price is envisaged.
4. Eligible Services and Related supplementary Services	4.1	All Services and related supplementary services to be rendered under the contract shall have their origin in eligible source countries, and all expenditures made under the contract will be limited to such Services and services. For purpose of this Bid, ineligible countries are stated in the section-4 titled as "Eligible Countries".
	4.2	For purposes of this Clause, "origin" means the place where the Services are mined, grown, cultivated, produced, manufactured, or processed, or through manufacture, procession, or assembly, another commercially recognized article results that differs substantially in its basic characteristics from its imported components or the place from where the related services are/to be rendered.
	4.3	The nationality of the Service Provider that supplies, assembles, distributes, or sells the Services and services shall not determine the origin of the Services.
	4.4	To establish the eligibility of the Services and the related services, Bidders shall fill the country of origin declarations included in the Form of Bid.
	4.5	If so required in the BDS, the Bidder shall demonstrate that it has been duly authorized by the firm of the Services to deliver in Pakistan (or in respective country in case of procurement by the Pakistani Missions abroad), the Services indicated in its Bid.
5. One Bid per Bidder	5.1	A bidder shall submit only one Bid, in the same bidding process, either individually as a Bidder or as a member in a joint venture or any similar arrangement.
	5.2	No bidder can be a sub-contractor while submitting a Bid individually or as a member of a joint venture in the same Bidding process.
	5.3	A person or a firm cannot be a sub-contractor with more than one bidder in the same bidding process.
6. Cost of Bidding	6.1	The Bidder shall bear all costs associated with the preparation and submission of its Bid, and the Procuring Agency shall in no case be responsible or liable for those costs, regardless of the conduct or outcome of the bidding process.

7. Contents of Bidding Documents	7.1	The Services required, bidding procedures, and terms and conditions of the contract are prescribed in the Bidding Documents. 	7.2	Section IX - Contract Forms The number of copies to be completed and returned with the Bid is specified in the BDS.
	7.4	The Procuring Agency is not responsible for the completeness of the Bidding Documents and their addenda, if they were not obtained directly from the Procuring Agency or the signed pdf version from downloaded from the website of the Procuring Agency. However, Procuring Agency shall place both the pdf and same editable version to facilitate the bidder for filling the forms.
	7.5	The Bidder is expected to examine all instructions, forms, terms and specifications in the Bidding Documents. Failure to furnish all the information required in the Bidding Documents will be at the Bidder's risk and may result in the rejection of his Bid.
8. Clarification of Bidding Documents	8.1	A prospective Bidder requiring any clarification of the Bidding Documents may notify the Procuring Agency in writing or in electronic form that provides record of the content of communication at the Procuring Agency's address indicated in the BDS.
	8.2	The Procuring Agency will within three (3) working days after receiving the request for clarification, respond in writing or in electronic form to any request for clarification provided that such request is received not later than three (03) days prior to the deadline for the submission of Bids as prescribed in <b>ITB 23.1.</b> However, this clause shall not apply in case of alternate methods of Procurement.
	8.3	Copies of the Procuring Agency's response will be forwarded to all identified Prospective Bidders through an identified source of communication, including a description of the inquiry, but without identifying its source. In case of downloading of the Bidding Documents from the website of PA, the response of all such queries will also be available on the same link available at the website.
	8.4	Should the Procuring Agency deem it necessary to amend the Bidding Documents as a result of a clarification, it shall do so

- c. Material Management (Purchasing and Inventory Management)
- d. Task Manager (Customized developed Task assignment application)
- e. Vendor Registration portal in MM module
- f. Admin Data Entry Screen
- g. Project System (Customized Non-SAP Developed Application)

Presently, NDRMF is undertaking a strategic initiative to establish a dedicated NatCat (Natural Catastrophe) Data Center. As part of this effort, the organization is in the process of acquiring the necessary hardware infrastructure. In alignment with this objective, NDRMF has decided to migrate its SAP hosting from the existing vendor's public-private cloud to an on-premises Data Center. The IT team at NDRMF has conducted thorough hardware and software sizing assessments, ensuring that the on-premises infrastructure is adequately configured to accommodate the existing SAP landscape.

SAP BASIS serves as the indispensable backbone of a SAP system, constituting a comprehensive set of tools and applications. This integral component facilitates seamless interactions with operating systems, databases, communication networks, and business application protocols. Its multifaceted role extends to streamlining the administration and maintenance of processes within the SAP environment. This encompasses crucial tasks such as system installation, load balancing, system configuration, and continuous performance monitoring of various SAP modules. Essentially, SAP BASIS plays a pivotal role in ensuring the efficient and optimal functioning of the SAP system, providing a robust foundation for organizations to manage their business processes with precision and reliability.

Historically, the vendor has been responsible for executing all critical BASIS operations in adherence to the cloud Service Level Agreement (SLA). However, with the imminent migration of the SAP system to our internally managed Data Center, a significant shift is expected. Post-migration, the vendor will cease to provide BASIS support. Therefore, SAP Basis Support Services shall be required on **Hourly Basis Model** (approx. 250 hours for one year).

### 2- <u>Scope of Work</u>

The consultant's primary responsibility will be to oversee and ensure the seamless migration of SAP from the current third-party hosting to an on-premises infrastructure. 
