ELIGIBILITY

1. This Invitation for Bids is open to all Bidders meeting the following requirements: -
 - Written request accompanied with attested copies of: -
 - a. Pakistan Engineering Council Certificate renewed for the year 2024-25 with Category having Specialization Code as mentioned against above must be provided.
 - b. The bidders as well as JV firms shall be in the active tax payer list (ATL) of the Sindh Revenue Board and Federal Board of Revenue, and will provide income Tax Returns for last three years and Bank statement for last one year.
 - c. Identity Card of Contractor / Managing Partner / Director of the firm/JV Firm.
 - d. Authority letter is required on 100 rupees judicial paper for contractor representatives to receive tender documents/ participation in tender.
 - e. All bids must be accompanied by a bid security in favor of Project Director GSC HESCO Hyderabad in the shape of CDR/Bank Guarantee from any scheduled bank of Pakistan and shall be valid 28 days beyond bid validity. The bid shall be valid for 120 Days.
 - f. Completion Time of the project is 150 days from the date of issuance of letter of commencement.
 - g. The bidder must have completed at least two contracts of same nature along-with its completion successfully as main contractor within Ten years awarded by WAPDA/NTDC/DISCOs/K-Electric. The consolidated value of these contracts must be more than or equal to the quoted amount for this tender.
 - h. The bidders must submit the copies of relevant work orders along with completion certificates duly attested by the sitting Officer (mentioning its name & contract number) of the Work order, Completion certificate issuing office.
 - i. The bidders / JV Firms must submit the affidavit of undertaking that the firm is not black listed from any organization; is/ is not under litigation with any department and all submitted documents are genuine.
 - j. The bidder should have an Average Annual Construction Turnover equal to half of the amount mentioned against this work during last three years certified from audited financial statement.

- A complete set of Bidding Documents may be purchased by any interested bidder, meeting with the eligibility / qualification criteria, on submission of a written application to the above office and upon payment of a non-refundable fee Rs.4000/- (Four Thousand Rupees). All the Bidding documents whether purchased or down loaded will not be entertained with-out non-refundable fee Deposit receipt.

 4. The successful bidder will have to submit 10% of the contract price as performance security in the form of CDR/Bank guarantee from any schedule bank of Pakistan.
