4. Bid Security (refundable) in the form of Pay Order / Demand Draft in the name of Civic Centres Company (Pvt.) Limited along with clear readable copy of CNIC must be delivered to the address above. A separate Pay Order for each vehicle should be submitted. (Pay orders can be submitted on any of above locations of NICL).
5. Bids should be submitted on EPADS on or before **24<sup>th</sup> September 3:00 PM** which will be opened on the same day at **3:30 PM** by the Bids Opening Committee in presence of bidders or their authorized representatives who may like to be present.
6. The successful bidders shall be required to pay all government applicable taxes & transfer fee. The balance of the offered price + Advance Tax (10% Advance Tax for filers & 20% for non filers) shall have to be submitted within seven days, failing which offer shall be cancelled and the ‘Bid Security’ shall be forfeited.
7. Vehicles shall be available for inspection between 9:30 AM to 4:30 P.M Monday to Friday at the places mentioned against each vehicle.
8. The Bidder(s) shall be disqualified who did not submit Bid Security (Pay Order in original) on any of the given addresses.
