**S. R. O. 1093 (I)/2015.**—In exercise of the powers conferred by section 27 of the Public Procurement Regulatory Authority Ordinance, 2002 (No. XXII of 2002), the Public Procurement Regulatory Authority is pleased to make the following regulations, namely:—

1. **Short title and commencement.**—(1) These regulations may be called the Eligible Bidders (Tax Compliance) Regulations, 2015.

(2) They shall come into force at once.

2. **Tax Compliance by the Bidders.**—(1) All procuring agencies shall procure goods, services and works from the firms, organizations, consultants, companies, contractors or suppliers who are active taxpayers as per Federal Board of Revenue (FBR)'s database *i.e.* Active Taxpayers List (ATL). This condition shall be mentioned in the bidding documents for all procurements.

(2) Payment to the bidders or suppliers shall be linked with active taxpayer status. If a contractor or supplier is not in ATL, no payment shall be made until the contractor or supplier appears on ATL of FBR.

(3) The above sub-clauses (1)&(2) will not be applicable in case of procurement through petty purchase and request for quotations.

**S.R.O. 1094 (I)/2015.**—In exercise of the powers conferred by section 27 of the Public Procurement Regulatory Authority Ordinance, 2002 (No.XXII of 2002), the Public Procurement Regulatory Authority is pleased to make the following regulations, namely:—

1. **Short title and commencement.**—(1) These regulations may be called the Public Procurement (Specimens for advertisement) Regulations, 2015.

(2) They shall come into force at once.

2. **Publication of Advertisement.**—(1) The procuring agencies shall advertise all procurement opportunities keeping in view the financial limit and manner given in rule 12 of the Public Procurement Rules, 2004. The specimens given at Annexures-I, II & III of these regulations shall be followed for the advertisement of Invitation to Bid, Request for Expression of Interest, and Proposals for Pre-qualification respectively.
