ADVANCE PAYMENT OF UPLOADING FEES TO PPRA Subject:

The Competent Authority (PPRA) has been pleased to approve implementation of Advance Payment Mechanism affective from 15th August, 2024. All Procuring Agencies shall be required to submit Tender / Evaluation / Advertisement uploading fees to PPRA in advance through online deposit/cheque/DD/Pay Order.

The Procuring Agencies can upload their tender(s) on PPRA website 2. with advance payment through any of the following methods:

- Online Tender Submission by PAs through Login IDs: In this method, the a) payment shall be deposited online in PPRA bank account and deposit slip shall be attached, as payment proof, with the tender / auction / evaluation notice to be uploaded on PPRA website. The Authority has developed an online invoice generation process for PAs through which they can generate / download invoice directly from the PPRA website. The online payment can be deposited in PPRA Bank Account No. PK17 HABB 0004540013100701 maintained with HBL, A Block, Pak. Secretariat Branch, Islamabad.
- b) Uploading Request by PAs to PPRA via email: In this method, all PAs shall attach scanned copy of payment proof preferably online deposit slip along-with their email request to PPRA. The tenders / evaluations shall be uploaded on PPRA website subject verification of advance payment.
- c) Uploading Request through Letter(s) to PPRA: In this method, the PAs shall attach with their letters the online deposit slip / crossed cheque(s) / Pay Order(s) / Demand Draft(s) with their letters as payment proof. The uploading shall be executed after verification of financial instrument.

Subject: INCOME GENERATION BY PPRA

10-

Section 9 of Public Procurement Regulatory Authority Ordinance No. XXII of 2002 provides that there shall be a PPRA fund to be utilized by the Authority to meet the charges in connection with its functions. Section 9(2) of PPRA ordinance provides that in <u>addition to the Federal Government allocations</u>, the fund <u>shall also comprise of grants</u>, income by investment by the authority and all other <u>sums or properties which may in any manner become payable to; or vest with the</u> <u>authority in respect of any matter</u>. In view of the above, PPRA has been sufficiently authorized to explore ways and means to generate its own income in line with other regulatory bodies.

2. One of the major functions being performed by PPRA is the continous monitoring of tenders which are up-loaded by Public Sector Procuring Agencies on its website <u>www.ppra.org.pk</u>. Deviations from Public Procurement Rules 2004 are pointed out to the respective agencies for taking corrective measures. According to Public Procurement Rule-12, all tender advertisements above Rs: 100,000 are also required to be uploaded on PPRA website. During the financial year 2008-2009 about 329 procuring agencies uploaded their <u>18630</u> tender advertisements on PPRA website. Since establishment of this facility in 2004, no charge has been levied the tender advertisements.

3. PPRA web site is useful for the procuring agencies and the suppliers. The advertisement of tender notices in print media is very expensive. All tender advertisements from Rs.1 lac to 20 lac are also required to be uploaded on PPRA website. Tenders above Rs.2 million are published both on PPRA website and in print media. This facility of uploading on PPRA website has been providing huge savings for the procuring agencies. However, a nominal levy of tender fee would generate income for PPRA without causing any additional financial burden on the procuring agencies.

4. The methods being used for uploading of procuring agencies tender advertisements include direct uploading (through user login), emails, faxes, letters and newspapers. PPRA intends to levy an initial fee of Rs.1000/- *(subject to variation) on each tender uploading by the procuring agencies to generate some income and to meet its expenses which will ultimately reduce reliance on government budget. This initiative, would help generate an income of approximately Rs.2 million annually.

5. Proposal at para 4 above may kindly be approved/for financial autarky of PPRA and a much needed right step to attain the essence of a regulatory body in the new regulatory regime to achieve the overall objective of improving governance, management, transparency, accountability and quality of public procurement of goods, services and works in the public sector.

Rule-12 of Public Procurement Rules-2004 stipulates the under mentioned mandatory method of advertisement on PPRA website: -

"Procurements over one hundred thousand rupees and up to the limit of two million rupees shall be **Advertised on the Authority's website** in the manner and format specified by regulation by the Authority from time to time. These procurement opportunities **may also be advertised in print media,** if deemed necessary by the procuring agency".

2. Precedence of advertisement on PPRA website over print media contained in the Rule is of the essence.

3. The PPRA Board, in order to lend sustainability and ensure neutrality of Public Procurement Regulatory Authority decided to charge a fee of Rs.1,000/- on each tender notice uploaded on PPRA website (www.ppra.org.pk) in terms of Section 9(2) of PPRA Ordinance, 2002.

4. All Federal Government entities are therefore requested to deposit procurement advertisement uploading fee of Rs.1,000 on each tender exceeding the value of Rs.100,000/- w.e.f <u>1st December, 2009</u> through a crossed cheque/demand draft/pay order in favour of Public Procurement Regulatory Authority, Islamabad.
