INTRODUCTION:

1. The Residents of KPT Flat Nos. FK-(05, 08, 09, 10, 12, 13, 15, 19, 20, 22, 23, 25, 27, 28, 33, 46, 47, 48, 53, 54, 55 & 56) building vide their application placed at S.No.1 have requested for the repair & maintenance works of official KPT accommodations, which are in dilapidated condition. The subject accommodations were visited by AXEN / Sub Engineer (KV) and they have observed that, the KPT Official accommodations are in much dilapidated condition and need repair works to make these in livable condition (photographs are placed at S.No.2).

Accordingly, AXEN (KV) has prepared an estimate placed at S.No.3(A) & 3(B) respectively, for attending the same through outsourcing as the same is beyond the scope of in-house arrangements.

It is pertinent to mention here that, no work have been done since last 05 years of the subject building.
