Remarks / Observation:

- Sample "3/4" (French Mustard Paste) Rejected due to taste (Mild), and poor consistency.
- Sample "3/4" (Baby Corn Cob) Rejected due to rotten, discolored and size.
- Sample "1/4" (Coca Powder Emperor Brand) not as per specification.
- Sample "4/4" (Cooking Salt) Rejected, expiry date no mention.
- Sample "1/4" (Pasta) Rejected, our requirement is colored pasta.
- Sample "1/4" (Icing Sugar) due to dusty / dull color.
- Sample "4/4" (Dry Plum) Rejected as plum were dry and blackish in color, however, spec specify that it should be golden brown.
