Technical Evaluation:

Bidder's solution submitted as per technical proposal must be capable to perform all functions and must meet all requirements mentioned in Scope of Work.

Compliance of all technical specifications mentioned in this Bid Document is mandatory. Technical evaluation to be done on compliant/non-compliant basis (without scoring or weightage). Below Specification on partially complaint proposals shall be declared as Non-compliant. Technical Compliance Matrix given in bid document to be used for Evaluation.

Technical Evaluation was conducted on 19th day of December 2019 and it was concluded that one bidding firm (M/s Islamabad General traders, Islamabad and M/s Khursheed enterprises, Islamabad) was technically non-compliant on the basis of technical specifications.

However, it was found that the firm (M/s Islamabad General Traders, Islamabad and M/s Khurshid enterprises, Islamabad) was found technically responsive and qualified for the financial evaluation.

Financial Evaluation Criteria:

Technically Compliant Bidders shall be considered for Financial Evaluation Responsive bidders on basis of total Quoted Cost (Inclusive of all applicable taxes and excluding any discount), shall be assigned ranking in ascending order i.e. bidder offering lowest evaluated price shall be placed at top and be called as "Lowest Evaluated Bidder".
